Dear Major Motherwell:

Confirming our telephone conversation of this morning and in reply to your personal letter, this is to advise that there is going forward in today's mail, a copy of the Interim Report of the Post-war Rehabilitation Council.

As I advised you this morning, the appendix to this report is a rather voluminous document and is not yet ready but is expected to be available within a few days. In the meantime, the King's Printer is not able to let me know exactly what the report is going to cost but advised that it will be in the neighborhood of \$1.50. Whatever the cost is, I will let you know later on.

In respect to the section on fisheries, I may say that so far as I am aware, no submissions have been made to the Committee, either by fishermen individually or by fishermen's organizations, nor have any submissions been made by canners or fish-processing organizations. The recommendations contained in the report are the result of a memorandum prepared by this writer. I am not a little disappointed that the fishing industry passed up what I think was a wonderful opportunity to at least get some constructive thought before the powers that be. As this is a personal letter I may say to you that the Post-war Rehabilitation Council did whittle down my recommendations somewhat in

respect to the future of Japanese in the fishing business.
My recommendation was emphatical that Japanese should not
be permitted to re-enter the fisheries of British Columbia.
