Mr. Reynolds ably presented the problems confronting the blueback trollers in the Nanaimo district at the above meeting and earnestly requested an increased price to the fishermen.

The canners carefully reviewed the market outlook for bluebacks and the disappointing quality of the fish now available, also the unusual small size of the fish at this time. After reviewing the costs of canning submitted by all packers, it was quite apparent that the cost of the finished article is at present in excess of today's selling price.


Until the quality of the fish improves or the market value increases, it is impossible for the canners to pay more than is now offered.

It was felt by the canners that if the problem was submitted to a fact finding committee, under the Fisheries Act, their position would be substantiated.

FISHURNING PRICE MEGOTIATIONS.

THE price of fish in British Columbia is partly the result of supply and demand, but is mainly the result of secret agreements by those powers that control the destiny of the fishing industry. These powers have their interlocking directorates and are organized to pay as little for fish as they possibly can. The only hope that the fisherman has for continued existence is successful counter-organization.

At a public meeting held in Nanaimo in April, 1934, the Deputy Minister of Fisheries told the fishermen assembled that the legislation introduced in the House is sponsored by organized interests and that fishermen are fools if they do not organize and protect their own interests.

Fortunately, the organization already exists—the British Columbia Trollers' Association. For a number of years the Association (under the name of West Coast Fishermen's Association) has protected your interests and now asks that you do yourself the favor of joining.

At the present moment the British Columbia Trollers' Association is an organization that is recognized by the Government and is consulted on all changes in the Fishing Regulations before they are put through. The Department values the opinion of the British Columbia Trollers' Association, but the value depends on the size of the membership.

Vital changes are in the offing; changes that are of tremendous importance to you. You, as an individual, cannot express your opinion in any way that counts; why not join an organization that can and does freely express its opinions and that looks after the interest of the trollers of British Columbia.

GAINS THAT HAVE BEEN MADE BY THE TROLLERS OF BRITISH COLUMBIA THROUGH THE ORGANIZATION OF THE BRITISH COLUMBIA TROLLERS' ASSOCIATION

- 1. Duty on gas engines and engine parts reduced from 27 per cent to 15 per cent together with freedom from the 6 per cent sales tax.
- 2. Dumping duty reduced on gasoline imported by the fishermen.

- 3. Success in our efforts to have the Department of Marine and Fisheries instal foghorns, lights, bell-buoys and marking on the West Coast.
- 4. Success in persuading the Department of Fisheries to close Alberni Canal, Coon Dog Bay, Barnet Pass, Baynes Sound and many other areas to seining.
- 5. Constant opposition to the reopening of these areas,—which have been applied for every season.
- 6. The West Coast Fishermen's Association started the movement to restrict the number of Japanese licenses, and the reorganized British Columbia Trollers' Association will carry on this idea to a successful conclusion.
- 7. The British Columbia Trollers' Association is not a Union, nor is it allied to any political creed. It is an association to safeguard the interest of trollers. It can not be considered as an organization dedicated to the principles of the strike, nevertheless, a number of successful strikes have been organized by its locals in different areas.

A few examples might be quoted:

- (a) The price of cohoes was raised by the efforts of the West Coast Fishermen's Association on the West Coast from 40c to 80c per fish.
- (b) The first year the West Coast Fishermen's Association worked at White Beach the price was raised from 35c to 60c for cohoes. The next year it was raised from 50c to 75c. After this, the Co-operative Association entered the field and the West Coast Fishermen's Association withdrew in their favor.
- (c) In 1930 a successful strike was organized at Millbank Sound, which maintained the price of springs at 14c all summer. This strike was so well organized that no time was lost, as the men fished and ran their own packers to Butedale.
- 8. The West Coast Fishermen's Association, in 1933, co-operated with other interested organizations in such a storm of protest that the Government cancelled the legislation calling for delivery within 24 hours of all fish at a cannery.

A number of very important questions are now being discussed in Government circles that are

vital to trollers. A few of them may be 1. The question of extending the Blueback close season until June 1st. 2. Seining in Blackfish Sound. 3. A close season for cohoe from October 31 to May 15. 4. Seining in southern part of Gulf of Georgia. 5. Clearing of slash and logs from streams. 6. The use of herring for reduction purposes. 7. The discontinuation of the public meeting of Mr. Found and the fishermen of different localities. Mr. Found says that he would rather meet delegates from Associations. Plus these items of general interest, there are two vital questions that have cropped up lately: 1. The question of the gasoline tax: The British Columbia Trollers' Association is undertaking a publicity campaign to persuade the Government to withdraw this tax that imposes so great a burden on the troller. 2. The question of the Japanese trollers invading Northern waters. As you may know, there has been an agreement in the past whereby the Japanese promised not to fish north of Alert Bay. Last summer a number of Japanese went beyond this line and trouble resulted. It is feared that there will be a repetition of this invasion on a larger scale in the coming season, and it will be desirable that fishermen organize so that all lawful steps be taken to check this menace from expanding to those remaining grounds where the white fisherman is free from Oriental competition. THE QUESTION IS: Will you be content to sit back and let others control the fishing industry? or Will you join us and become a member of an organization that has a definite voice in moulding the conditions under which you earn your living? The fee is 50 cents.

MOTION: moved by Mr. Gaunt that a wire be sent to Prime Minister R. B. Bennett demanding the presence of Mr. Found at our general meeting, pointing out that the Association went to the inconvenience of changing the date of the annual meeting to convenience Mr. Found. Seconded by Mr. Ormond.

Motion carried.

MOTION: moved by Mr. Lloyd that the resolution concerning the matter of enforcing of Fishery Regulation be adopted. Seconded by Mr. Hauberg.
Motion carried.

MOTION: moved by Mr. D. Rogers that the resolution concerning the matter of the Japanese trolling north of Blackfish Sound be adopted. Seconded by Mr. A. Gaunt.

Motion carried.

MOTION: moved by Mr. Ged. Day that the northern boundary of Blackfish Sound be established as a line from Bold Point to Donegal Head to Pearce Islands. Seconded by Mr. A. Gaunt. Motion carried.

MOTION: moved by Mr. Lloyd that a resolution drawn up by him to stop combines in the buying of fish in the B. C. be adopted. Seconded by Mr. Jack Rogers.

Motion carried.

AMENDIALERT: moved by Mr. Gaunt that the word "farmer" be out out of the resolution. Seconded by Mr. D. Rogers.
Amendment carried.

MOTION: moved by Mr. Gaunt that the area included in the line from Mexican Point on Hope Island to Cape Sacott be closed to seines and gillnetters. Seconded by Mr. S. Vollmers.

Note. The cohoe runs of this district are nearly depleted because of illegal fishing being carried on.

MOTION: moved by Mr. Gaunt that this association go on record protesting the insulting manner in which the indian agent at Alert Bay treated Mr. A. Lloyd when he reported the infraction of the lwa by a seine boat in Hardy Bay. Also a protest be forwarded to the Fishery Department at Ottawa. The court was told by the indian agent that Mr. Lloyd was doing this in the hope of getting moiety of the fine. Seconded by Mr. J. Rogers.

Motion cerried.

MOTIONS moved by Mr. Eddington that we go on record as being against Dean R. W. Bronk and Prof. H. F. Angus being on the University of B. C. Staff, as they are taking an active part in the attempt to obtain the franchisement of orientals. We request their immediate dismissal. Seconded by Mr. George Day. Motion carried.

MOTION: moved by Mr. H. Vollmers that we send Mr. Hanna a wire to get him to attend our meeting tomorrow. Seconded by Mr. Eddington. Motion carried.

MOTION: moved by Mr. Eddington that we ask Mr. Neill if he can help us to get u the following;

a light on Mexicana point on Hope Island,

a whisle bouy at Goose Island at the end of the Goslin Rocks.

a spar bouy or light on Grant roof, outside of Harwood Is. a light on Marl's ledge opposite Salmon River.

seconded by Mr. Rogers. Motion carried.

MOTION: moved by Mr. Haubers that we recommend to the Government that any act in the Criminal code having a clause or part provisiding for a moiety to the informer be amended by having such a clause or part removed. Seconded by Mr. Henry Vollmers. Motion carried.

MOTION: moved by Mr. H. Vollmers that Mr. Eddington and Mr. Chamberlain see that this meeting set publication throughthe Vancouver papers. Seconded by Mr. Jack Rogers. Motion carried.
