WE, the undersigned owners of property in the Little Hountain Subdivision situated in the City of Vancouver, Province of British Columbia, and lying between Cambie Street on the east, Ash Street on the West and King Edward Avenue on the North, submit the following for your consideration and action:

- 1. That each of us purchased the property set opposite each of our names from you with the definite understanding-
- (a) That we were not purchasing for speculation or resale:
- (b) That we were to construct suitable residences each to be worth not less than \$4000.00 and that it was to be a high class residential area;
- (c) That it was your intention to exclude Orientals and Asiatics of every kind, and that you would not sell a lot to anyone of that extraction:
- 2. That we are informed and believe that the South West corner of 27th and Cambie has been sold to a Mr. Virtue who is now constructing a house thereon.
- Mr. Virtue is either constructing the house as an agent for an Oriental, one Jang, or he is constructing it with the intention of reselling it to the said Jang, either of which is against the restrictions placed on the property when we purchased.

WE therefore request you to take the necessary steps -

- To prevent the said Mr. Virtue from disposing of the said house and lot to, or allowing an Oriental to occupy the same;
- 2. To sell all other lets within the seid subdivision with a restrictive covenant preventing the disposal or occupancy of same by Orientals or Asiatics.
