Classification of Rt. Hon. Ian Mackenzie's Papers

Letters of the alphabet have been used to group together files on certain subjects. Thus, "A" for Alaska. Subdivisions of the main subject are indicated by secondary letters of the alphabet. Thus, "AB" for Alaska Highway opening ceremonies. No cross-indexing has been attempted. Nor can it be certain that the classification is in all respects accurate, since the only data available were (a) crude headings inscribed on each file at the time they were examined in November, 1949; and (b) memory.

The former so-called Index is merely a list of the crude headings, with the original files numbers utilized in the filing procedure of the minister's offices in Veterans Affairs and National Defence. The lists are based on the cabinet drawers in which the files were placed and in only a few cases was the original grouping related in any way to subject matter.

It is hoped that the grouping hereunder will be of some assistance (although not an infallible guide) in any search for specific information that may be made.
