The Committee begs to recommend to Council the adoption of the following report:-

1. Re Objection to Oriental Penetration in 5800 Block, Highbury St.

,

Petitions, signed by owners of property in and near the 5800 Block Highbury Street, were received, protesting the sale recently of property situated at 5810 Highbury Street to an Oriental and requesting that action be taken to prohibit further Oriental penetration in the better class residential areas of the City.

RECOMMENDED that a Special Committee comprising the Chairman (Ald. Buscombe), Secretary Zoning Matters and the City Solicitor, be appointed to bring in a report, containing recommendations, and a draft by-law which would restrict Orientals from owning or occupying property for residential purposes in any other than the recognized localities for Orientals.

2. Re Alleged Proposal to develop

<u>Kitsilano Reserve as a Shipbuilding Site.</u>
