CABINET WAR COMMITTEE

Re: B.C. Security Commission - travel of Japanese in Canada

At the meeting of September 2 2nd, Cabinet war Committee approved the recommendation of Defence Council for amendment of the B.C. Security Commission Order No.1 New Series, to provide that persons of Japanese race in British Columbia must obtain an R.C.M.P. permit prior to travel, for any purpose whatsoever, a distance of five (5) miles from their residence. This approval was subject to the concurrence of the Department of Labour and the Department of Justice (R.C.M.P.).

The Minister of Labour has now reported that the proposed amendment has been the subject of a conference between officials of the two departments. It was the unanimous opinion of these ments. The R.C.M.P. further testify that no Japanese in Canada has been active in an attempt at sabotage since the war began and they are satisfied that the present security measures are sufficient.
