RULES OF THE SCUTHERN ALBERTA YOUTH COUNCIL As adopted at the meeting of April 28, 1946.

- 1. Any club that wishes to join the Council shall signify its' desire by handing in a list of its' executives, official delegates and approximate number of members, in writing, to the executive seceretary of the Council and shall notify the Council of any change of staff.
- Each club to have 3 official delegates to the Council.
- 3. Voting power shall be given to the organized co-operating members of the Council and the Executive, with 3 votes for each group. Any visitors at Council meetings shall be voted in as corresponding members, granting them a voice in Council affairs but no vote. A roll call of Council members shall be held at the beginning of every meeting. Every delegate votes as an individual (that is, to have 3 votes, the 3 delegates or their separate proxys for each club must be present) and be responsible to his club except at election time.
- 4. Registered clubs must attend at least 75% of the meetings from the time of registering before they are eligible to vote at election.
- 5. Meetings to be held every 1st and 3rd Sunday of each month at the Y.M.C.A. at 8 p.m. in every month from November to May. Summer meetings and other emergency meetings to be held at the call of the executive. The executive also has the power to cancel any meeting.
- 6. Meetings to be conduct d in English.
- 7. Every meeting is to be carried on with the president, vice president or second vice president in the chair and in case none of these three are present, the Council can elect a temporary chairman.
- In order to enjoy the privileges of full voting membership in the Council, every club is expected to give financial aid when called for.
- One third club attendance will constitute a quorum. 9.
- Whenever a decision is deemed necessary, a 75% majority must be had 10. in the form of a secret ballot.
- 11. Parliamentary procedure shall be observed at all meetings.

MINUTES OF THE SOUTHERN ALBERTA YOUTH COUNCIL

NOVERMBER 17, 1946.

- The president opened the meeting, extending his sincere greetings to all the delegates. Thereupon he stated that he was handing in his resignation as he was leaving this part of the Province and asked the first vice-president to take over the chair. Consequently under the chairmanship of the new president, the meeting got under way.
- The secretary gave a brief summary of the previous meeting.
- A motion was made by Hiromu Fujiki and seconded by Mas Sunada that the minutes be adopted as read. Carried.
- The secretary gave a very sketchy description of the special meeting of May 25th between the Joint Committee and the Council.
- Mr. Kyoto Shigehiro, registrar of the Council summer camp at Waterton gave a descriptive account of the camp. He stated that the Council was \$7.06 on the wrong side of the ledger.
- A discussion took place regarding our report of the camp to the New Canadian. It was noted that our report had been cut to such an extent that the report lost it's original meaning.

A motion was made by Miss Bartling and seconded by Norman Ikebuchi that the reporter write in to the New Canadian regarding this matter.

- A motion was made by Miss Bartling and seconded by Norman Ikebuchi that the president's resignation be accepted. Carried.

A discussion followed with regards to the President's resignation.

The first vice-president was automatically voted into the vacancy created by the president's resignation. After a somewhat lengthy discussion, the consensus of opinion expressed was that this year, the office of president will demand more of his time, energy and effort than ever before, and that also owing to the nature of the new president's occupation, it was deemed advisable if the Council were to create the office of chairman and elect someone to this position to preside at all Council meetings in place of the President. By so doing, it would ease the burden upon the president

A motion was made by Yosh Nakamura and seconded by Eigi Shigehiro that the Council elect a chairman. Carried.

Malcolm Fukami and Kyoto Shigeniro were nominated for the chairmanship, and Kyoto Shigehiro was subsequently elected. He therefore took over the chairmanship of the meeting from the president.

- Mr. Cameron:

It was stated that Mr. Cameron, former General Secretary of the Y.M.C.A. had done much to help the Japanese Young People during his stay, therefore and expression of our thanks was in order.

A motion was made by Roy Oshiro and seconded by Hiromu Fujiki that in the absence of the corresponding secretary the executive secretary send Mr. Cameron a leeter of appreciation. Carried.

- Questionnaire:

The purpose of the questionnaire was given, viz., that it was the Council's desire to assist the Lethbridge Consultative Committee who will shortly undertake to seek abrogation of the existing agreement between the Department of Labour and the Lethbridge City Council. Under the terms of the agreement, persons of Japanese origin are not permitted to reside nor seek employment within the City Limits. The questionnaire would help immeasurably in that it will give us imporquestionnaire would help immeasurably in that it will be directed to the Consultative Committee.

An opinion was voiced by Mr. Hiro Aoki that approximately 95% of the people in the Lethbridge Northern would be willing to stay in Alberta if all discriminatory restrictions were lifted.

Due to the poor response given the questionnare, a suggestion was made that the Council send out another questionnaire, this time making it a little more comprehensive.

A motion was made by Yosh Hattori and seconded by Hiromu Fujiki that the executives also draw up the 2nd questionnaire. Carried.

- It was decided to table the question of the Citizens' Forum until the next meeting.
- National Federation:

An opinion was expressed that from all indications, the proposed National Federation will be somewhat similar to the Japanese Association which functioned at the coast. The Council has already taken a stand as to along what lines such a federation should follow. Are we going to let the powers that be repeat the failure or are we going to carry on with our convictions? It was suggested that should the federation take shape contrary to our expressed ideas, the Council study the feasibility of joining the Youth Congress.

The change of site for the National Convention from Winnipeg to Toronto was discussed. Because the Council was not consulted nor notified as to the change, many of the delegates voiced their indignation.

- A motion was made by Miss Bartling and seconded by Roy Oshiro that
"We voice our strong disapproval of the method of calling an National Convention. We feel that we in Southern Alberta should have been consulted as to the time and place for such an convention and if the Consulted as to the time and place for such an convention of every point Ontario Provincial Committee wishes the co-operation of every point in Canada that they should ask for opinions and consider the opinions of every interested group." Carried.

It was suggested that every delegate take the matter of the National Federation back to their respective organization and discuss it.

- Vancouver Consultative Committee:

Miss Bartling stated that the Vancouver Consultative Committee was about to publish a new pamphlet on Japanese Canadians, however that they were \$400 short of the amount needed for the publication. She suggested that the council do something about this meater and asked that the delegates talk it over at their meetings.

- A motion was made by Roy Osniro and seconded by Hiro Aoki that the Council nave it's meetings in the afternoons instead of the evening. Carried.
- Date for the next meeting was set for December 1, 1 p.m.
- A motion was made by Roy Osniro that the meeting adjourn.
- Meeting adjourned at 11:45 p.m.

MINUTES OF THE SOUTHERN ALBERTA YOUTH COUNCIL

MEETING OF DECEMBER 1, 1946.

- The meeting was brought to order at 2 p.m.
- The secretary read the minutes of the last meeting.
- A motion was made by Kaz Iwaasa and seconded by Toru Iwaasa that the minutes be adopted as read. Carried.
- Questionnaire:

The various aspects of the questionnaire was discussed. It was decided to leave the question of just who should all fill out the questionnaire forms to the discretion of the clubs.

- National Federation:

The larger part of the afternoon was spent discussing the National Federation and the Convention. Under the guidance of the Secretary the whole matter was reviewed; the result of which cleared up many misconceptions and misapprehensions. The need for further discussion on the National Federation was stressed and it was felt that the Council should have some sort of a discussion during the restive season.

A motion was made by Miss Bartling and seconded by Yosh Nakamura that we instruct either the executives or appoint a committee to plan a program of discussion for a Christmas meeting and that this program be sent to every group for further thought so that each group can come in prepared to thrash out the question of the National Federation. An Addition was made to the aforementioned motion that in the mean time, each club discuss this individually and then at the next meeting discuss it together. Carried.

As a result of the above motion, Miss Bartling and Min Takada were elected and this committe of 2 was delegated authority to appoint any other persons whom they saw fit.

- Circular:

After a lengthy discussion it was felt that the publication of the Council Circular should be revived. The following persons were appointed to the editorial staff.

- Citizens' Forum:

Miss Bartling outlined briefly just what the Citizens' Forum was.

All groups interested in joing the forum were instructed to get in touch with Mr. Tweedie, Department of Extensions, University of Alberta, Edmonton, Alberta.

- Vancouver Consultative Committee:

A motion was made by Kaz Iwaasa and seconded by T. Maruno that the Council solicit donations from the different clubs and forward it to the Consultative Committee. Carried.

- Social:

It was noted that last year, in fact already this year, socials were need with far too little time in between. To insure against any further occurance of this nature it was suggested that all parties interested in sponsoring social functions, first get in touch with the social registrar and make known their intentions and to see if the date is open.

A motion was made by Mas Sunada and seconded by Toru Iwaasa that Miss Marion Hattori be appointed as social registrar. Carried.

A motion was made by Kaz Iwaasa and seconded by Stan Kanegawa that the Council make arrangements to meet with the Consultative Committee to discuss our program of action regarding the franchise, rights and privileges. Carried.

A motion was made by Mas Sunada and seconded by Stan Kanegawa that we select a committee to approach the Consultative Committee. Carried.

The following persons were elected to the Committee.

A motion was made by Miss Bartling and seconded by Norman Ikebuchi that the secretary immediately write the Consultative Committee to ask for an audience. Carried.

A motion was made by Mas Sunada and seconded by Kaz Iwaasa that we increase the number of the committee to 5. Carried. Consequently Min Takada was appointed as the 5th member of the Committee.

- A motion was made by Mas Sunada and seconded by Yosh Nakamura that we give a vote of thanks to the girls who helped in the refreshment at the last conference. Carried.

A motion was made by Yosh Nakamura and seconded by George Sakumoto that we send a letter of thanks to Miss Eva Saito and George Tamaki for coming down for the Conference. Carried.

- Waterton:

Miss Bartling stated that there was a very likely possibility that we might be able to hold our summer camp early in the season, possibly around July 1st, provided of course we get in our bid for the camp good and early. A show of hands indicated that the majority of those present preferred the July 1st week-end to our late July date of the last 2 years. It was decided that this matter will be further discussed at the next meeting.

MINUTES OF THE SOUTHERN ALBERTA YOUTH COUNCIL MEETING OF JANUARY 26, 1947.

- The meeting was brought to order at 2:25 p.m. by the chairman.
- The secretary read the minutes of the last meeting.
- A motion was made by Yosh Nakamura and seconded by Kaz Iwaasa that the minutes be adopted as read. Carried.
- Circular:

Once again the clubs were reminded to send in their contributions to the circular. It was hoped that the circular would be out by the end of next week.

- Consultative Committee:

At the last meeting, it was stated that of late, there was no effort being directed by the Consultative Committee towards the recognition of our inalienable rights as Canadian citizens and thus a meeting with the Committee is desirable to discuss this vital matter. In answer to our letter, the Committee stated that they would meet a delegation of the Youth Council on January 27.

Adiscussion ensued as to what matters should be brought up to this meeting. Some of the suggestions were:

- naturalization- whether application for citizenship by Japanese Nationals would receive the same consideration.
- property loss question is the Committee in contact with the Toronto and Vancouver Committees on this matter.
- trade licenses why we are refused trade licenses.
- status of residence permanent or temporary.
- franchise
- land purchase
- regarding agreement between City of Lethbridge and Department of Labour. Making an issue of the agreement.
- Re: Activation of Organizations:

It was stated that the Sogoenjokai was unwilling to take a hand in the matter of re-organizing the youths of the Picture Butte area. However, it was stated that there was a movement afoot to re-organize the Picture Butte Y.W.B.A.

In answert to our letter of invitation to join the Youth Council to the Nisei Christian Fellowship group of Taber, it was stated that they would give the matter their serious consideration at their meeting of January 24.

No word was received as to the T.D.N.A., Coaldale Cubs and the Coaldale Y.M.W.B.A.

MINUTES OF THE SOUTHERN ALBERTA YOUTH COUNCIL MEETING OF FEBRUARY 23, 1947.

- The meeting was brought to order by the chairman at 3:00 p.m.
- The secretary read the minutes of the previous meeting.
- A motion was. made by Ed Shimbashi and seconded by Winky Kimura that the minutes be adopted as read. Carried.
- The treasurer gave a report of the Council funds. It showed a balance on hand of \$123.04.
- A motion was made by the treasurer and seconded by Kaz Iwaasa that the treasurer's report be accepted. Carried.
- Joint Committee Meeting:

The chairman gave a report of the meeting of February 15th between the Joint Committee and the Youth Council. He stated that three topics were discussed, viz., property loss question, delegation to Edmonton to confer with Premier Manning and the petition. He said there was a clash of opinion as to what course of action the Japanese in Southern Alberta should take. The Joint Committee stated that the approach to the Provincial Government is of the prime importance, and on the other hand the Council maintained that representation to Ottawa should be the 1st step. The Joint Committee had already made definite plans to send a delegation consisting of A. G. Virtue, Mr. Sakumoto and requested that a representative from the Youth Council also be included in the delegation.

A motion was made by Kaz Iwaasa and seconded by Winky Kimura that we send a representative from the membership of the Youth Council to Edmonton with the Joint Committee delegation. Carried.

Mas Sunada was elected to represent the Council and in the possibility of his not being able to go, Min Takada was appointed as an alternative.

- Mr. Kaz Iwaasa stated that in an answer he received from the Justice Department regarding application for Canadian Citizenship by Japanese Nationals, it said that at the present moment Japanese National applicants will not be considered.
- Circular:

A discussion took place regarding the indifference that is being shown by the niseis and lack of harmony between the isee and the niseis. It was agreed that such an unhappy state of affairs should be rectified and various ways and means of attaining this desirable state were discussed. It was felt that more than ever before, the publication of the Council Circular was necessary.

- A motion was made by Kaz Iwaasa and seconded by Winky Kimura that we, in the circular, put in what the Council has done, point out the way we have to go and mince no words in pointing out all our faults and have a translation of some of the parts that would be of interest to the isseis. Carried.

Besides the editorial staff, the following persons volunteered to help with the publication of the circular which was to be out by March 9.

Kaz Iwaasa, Kyoto Shigehiro, Winky Kimura, Hisako Yahiro, Terry Mivashita.

A motion was made by Miss Bartling and seconded by Ed Shimbashi that every club send in a write-up expressing their opinion of the Council to be published in the circular. Carried.

- Telegram:

A motion was made by Winky Kimura and seconded by Roy Oshiro that the Youth Council send telegrams protesting the Government's proposal to re-enact the travel and fishing restrictions. Carried.

"We, the Canadians of Japanese origin in Southern Alberta urge the deletion of clause continuing control on the movement of Canadians of Japanese origin and also clause continuing the ban on fishing license for Canadians of Japanese origin, contained in the Transitional Powers Act 1947. Petition from evacuees of Southern Alberta follows.

MINUTES OF THE SOUTHERN ALBERTA YOUTH COUNCIL MEETING OF FEBRUARY 9, 1947.

- The meeting was brought to order at 2:40 p.m.
- The secretary read the minutes of the last meeting.
- The minutes were declared as adopted.
- Waterton:

Matters pertaining to the various aspects for the undertaking of a camp program were discussed.

A motion was made by Roy Oshiro and seconded by Miss Miyo Nakashima that the Magrath Y. P. U. be appointed as the Camp Committee for this coming session. Carried.

A motion was made by Ed. Shimbashi and seconded by Miss Hisako Takahashi that there be a committee of one or two for each club, selected to act as publicity agent for this camp program and they be responsible to the main committee, which is Magrath. Carried.

A motion was made by Ed Shimbashi and seconded by Kayo Nakamura that the Youth Council accept the offer as given by Mr. Kennedy of the Canyon Church Camp Committee. The offer is, to wit: transportation by greyhound bus - \$3.00 return; food at the rate of 75¢ per person per day.

Meeting with the Lethbridge Consultative Committee:

The secretary gave a brief report of the meeting between the Youth Council and the Consultative Committee. He outlined the various questions that the delegates put to the Committee and the answers that they got. He stated that from the point of view of the delegates, the meeting was not what might be termed a success, in fact it was downright discouraging. The attitude of the Committee seemed to be, matters should be left as they are and in due course it will right itself. To support this argument they stated that girls are being allowed to work in the City without applying for permits and that a considerable number of males were also being employed within the City limits. Our rejoinder to this statement was that although the girls, in many cases, have not applied for permits, never-the-less they are required to have them and that a "blanket" permit had been made out by the Department of Labour. Also that the police are fully cognizant of where the men are working and residing. The reason why prosecution under the agreement is not being carried out is because the City Council is not sure of the ground which they are standing on. That is to say that they, themselves, are dubious as to the legality of the agreement. Another reason why the Consultative Committee was seemingly unwilling to take action is because of the political affiliation of some of it's members, especially the executives.

- Presbytery:

The chairman gave a report of the Youth Delegation that attended the United Church Lethbridge Presbyterial meeting on February 5th. He stated that the purpose of the delegation was to put in a plea asking the ministers to enlighten and arouse public opinion by preaching to their congregation and talking to individuals about the unfair legislatation that the Japanese Canadians are placed under. Report of the Southern Alberta Joint Committee

The present Southern Alberta Joint Committee is constituted by three major organizations in Southern Alberta, viz., the Lethbridge Northern So-go Enjo Kai, representing 750 members, the Taber Aiyukai representing 450 members and the Coaldale Fujokai representing 700 members. Therefore the total number represented by the Joint Committee is about 1500 members, constituting 75% to 80% Japanese.

On March 5th 1948, the Sogoenjokai had held a representative meeting at P.B Japanese Hall to decide the attitude toward the National JCCA. After careful study of the report of George Tanaka, the National secretary on his recent visit, the Sogoenjo kai passed a resolution to co-operate closely with the National JCCA to solve the following problems which we consider has a national significance in nature.

- to remove the restriction on movement imposed on J-C

- to obtain fishing rights

- to ask the Dominion Government the financial assistance for rehabitation and resettlement.

- the right of J-C to return to Canada.

The sogoenjokai also passed a resolution urgin the Raymond District Citizens League to return to the J int Committee.

On March 22nd, the second Joint Committee meeting in a month was held at the YMCA to decide the final attitude tward the national JCCA. The delegates of the following organizations were present at the meeting

Lethbridge N rthern Sogoenjokai Taber Aiyukai Coaldale Fujokai Raymond District Citizens League Alberta JCCA chapter

The Joint Committee asked the RDCL to return by a clean-slate principle to form the strong provincial chapter of the National JCCA. We proposed that the Sogoenjokai be changed to the Lethbridge Northern chapter. The Taber Aiykai be changed to the Taber chapter. The Coaldale Fujokai be changed to the Coaldale chapter. Edmonton and Calgary were also urged to form their chapters.

The Raymond District Citizens League offered counter proposal to the Joint Committee asking recognition of the already established provincial chapter until such time that the strong provincial chapter is formed. They assured that after strong united provincial chapter was being formed, they would amalgamate with the already established provincial to form the Raymond chapter. This proposal was approved by the Joint Committee and the return of the R.D.C.L. was completed.

Now the four major organizations are in complete harmony and after the delegates return from the Winnipeg National Conference we planned to form a strong provincial chapter including Edmonton and Calgary. The meeting had als decided the following minor point

Each organization send 1 delegate form every 100 members counting half and higher fractions as unit and disregarding the rest.

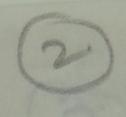
Mr. Sakumoto gave the report of the 2nd National JCCA Conference in Japanese.

Mr. Tanaka spoke on the fishing and travel restrictions that still apply to Canadians of Japanese origin. He stated that he thought veterans could travel anywhere but found out that nisei veterans also must have permits to travel. He stated that in B. C. there or was over 22 laws and order against the Japanese and that his recent visit to Vancouver and Victoria was to fight against these orders. He mentioned the B.C. Crown Timber Act and the franchise as specific examples. His work in B. C. was xxx a result of the decesion of the delegates at the 2nd National Conference, to send the executive secretary to Victoria and lobby against these discriminatory legislation and also to help organize the B. C. JCCA. In approaching the cabinet in Victoria they sought to have the public support and this was done by enlisting the support of the press. In going to the press Mr. Tanaka stated these discriminations apply to all xxx Japanese Canadians in Canada regardless of where they lived. According to the Canadian Citizenship Act passed in 1947, all Canadians in Canada should receive full rights and full privileges. The publicity received in the papers were very good and the public was altered alerted to the situation. Although April is a very busy month and it is extremely difficult to see anyone, we were very fortunate indeed in seeing Mr. Gordon Wismer and Premier Johnson. He stated that the government passed a resolution whereby all Japanese can work on Crown Timber land east of the Cascades, also that all employment disabilities will be lifted east of the Cascades.

Co-operative Committee:

Race Relations:

"all people in Canada, work together, help each other for our mutual benefit for the welfare of Canada, to make Canada a better nation."

He stated that the Canadian Jewish Congress, an organization that is similiar to the JCCA, helped us during the war and now they are requesting the support of the JCCA to push the enactment of a F.E.P.A. He stated that in Canada we have no such law and that such a law is desirable because it would make economic discrimination. Discrimination is a disease he stated. To destroy it we must have education and law (FEPA). Only then, can we hope to do away with with discrimination. The National JCCA is interest and concerned about the FEPA for Canada because we, as a discriminated minority, now what it is to be discriminated against.

National JCCA:

The national JCCA must have a strong foundation and the 1st foundation is the Provincial JCCAs. The Alberta JCCA must have the support of all the local organizations. All the local organizations must support the JCCA. Local Organizations must have the full support of the members, because the members is the most important foundation. The Japanese Canadians across Canada is the most important foundation and we must try to influence wkkers them to support the local organizations, support the leaders. It is the same old story everywhere. Only a few isseis and niseis work hard year after year to keep together the local organization. It is very expensive, it is very discouraging; it is because of them that we have a local organization, a National Organization. It is very important that all the Japanese in Canada support their leaders and the isseis and niseis to work together. It is absolutely necessary because if we don't do this, we will not have a strong JCCA and we must have a strong JCCA if we are going to work best and effectively for the Japanese in Canada, To prepare the welfare of the future, we must think ahead and lay our foundations. It is to co-operate with the other minority group in Canada and work with them thereby creating friendship and goodwill. We must think ahead.

- Consitution:

- Recommendation of Coaldale:

The delegate from Coaldale stated that there should be set-up an advisory board of some of the elder people in this district. Although the constitution limits membership from 18 to 70 years, they felt that there are some quite capable people who do not come within this limit. In this advisory board, there also should be the 4 Japanese ministers and preachers. They stated that by setting up such a board we will get fuller coopperation and help from the people.

This suggestion was tabled until the return of the constitution Comm.

- Re: oldetimers:

Suggestions were asked as to how best we can bring the old timers into the JCCA. Varied opinions were expressed regarding this matter. Some thought that this matter should not be treated seperately, maintaining that were to do so, it would be discrimination of a sort, to single them out as something special. This, we must avoid at all costs.

A motion was made by George Higa and seconded by Roy Oshiro that in order to facilitate the local chapter of the JCCA and in order to get the support of the old time residents of the province, the provincial chapter include in any publication, some note to arouse their interest. Motion defeated.

- Resolution:

A motion was made by Malcolm Fukami and seconded by George Higa that the following resolution be adopted.

"Whereas, the restrictions imposed upon Japanese Canadians are unjustified and undemocratic, and such discriminations can be made a precedence and thereby can reflect upon other minorities in Canada, and whereas such discriminations are contrary to the democratic ideals upon which Canadian society is based, therefore be it resolved that this 2nd provincial JCCA conference ask the government at Ottawa and the provincial government at Victoria to cancel the restrictions immediately.

- A resolution was made by Malcolm Fukami and seconded by Ted Aoki that the provincial JCCA chapter issue a pamphlet from time to time to disseminate information and to educate ourselves and to make the indifferent people aware of their obligation, if it is financially feasible. Carried.

The executive committee to determine what consitutes feasibility.

A motion was made by Mr S. Aoki and seconded by Malcolm Fukami that the Alberta JCCA chapter make a study of conrete ways of further enhancing the economic and social welfare of the people of Japanese origin in Alberta. Carried.

It was recommended that the Japanese should take advantage of this service and make use of its facilities as the library is there to serve the people.

- Waterton:

Min Takada brought the matter of the Waterton Camp to the floor. He stated that for the past three seasons the United Church has been very kind in extending to us the use of their Canyon Church Camp at Waterton, and that they had also extended the same invitation to us this summer. In the past, the camp has been under the sponsorship of the S.A.Y.C., however, with the formation of the JCCA, the S.A.Y.C. is now but in name only, therfore the matter of the sponsorship of the camp is very important. Mr. Takada's recommendation was that the JCCA sponsor the camp.

A motion was made by Min Takada and seconded by Miss Coleen Fukunaga that the Alberta JCCA spondor the Waterton outing this summer. Carried
