Certified to be a true copy of a Minute of a Meeting of the Committee of the Privy Council, approved by His Excellency the Governor General on the 17 September 1947.

The Committee of the Privy Council have had before them a report dated lith September 1947, from the Secretary of State, stating that, after further consideration of the Order in Council P. C. 1810, the 18th July,1947, providing for an inquiry into property claims of Japanese persons evacuated from the coast of British Columbia as a war measure, he is of opinion that the terms of reference should be expressed in terms in line with the Fourth Report of the Standing Committee of the House of Commons on Public Accounts, which Report dealt with the general administration and liquidation of property owned by Japanese evacuees and was concurred in by the House of Commons.

The Committee, therefore, on the recommendation of the secretary of State, advise that the terms of reference contained in the Order in Council P. C. 1810 aforesaid be amended:

- By striking out paragraphs (a) and (b) of Clause numbered 1 and substituting the following:
 - "(a) that real and personal property vested in the Custodian pursuant to the above mentioned Orders was disposed of by the Custodian for less tham the fair market value thereof at the time of sale resulting in loss to the Claimants equal to the difference between the amounts received from the sale and the fair market value aforesaid; and
 - (b) that personal property vested in the Custodian pursuant to the above mentioned Orders was lost, a destroyed or stolen while in the possession or under the control of the Custodian or some person appointed by him, with the result that the claimant suffered a loss equal to the fair market value of the property at the time when the same was lost, destroyed or stolen: provided that no claim shall be considered in respect of property lost, destroyed

or stolen while under the custody, control or management of any person other than the Custodian, appointed by the owner of the property."

2. By striking out the words "for failure of the Custodian to exercise reasonable care "from Clause numbered 2.

DRAFT STATEMENT BY THE CO-OPERATIVE COMMITTEE ON JAPANESE CANADIANS

The Minister of Justice has announced the terms of an Order-in-Council amending the Order-in-Council which appointed a Commissioner to investigate the property claims of Japanese Canadians. We enclose a copy of the amending order.

This amendment removes the most serious objection taken by us to the terms of reference set out in the original Order, namely, that it was necessary for a claimant to prove that his loss was caused by lack of care on the part of the Custodian or his agents.

We urged that the case of the Japanese Canadians in no way depended upon any lack of care on the part of the Custodian, and that in all cases where property was sold at less than a fair market value, compensation should be made.

We were so convinced that the original terms of reference imposed an impossible or extremely difficult burden on the claimants that we seriously contemplated advising the Japanese Canadians who might have claims, not to present them to a Commission whose powers were so restricted.

we therefore welcome the amendment contained in the new Order-in-Council insofar as it removes this objection and enables all those whose property was vested in the Custodian, and was sold at less than a fair market value, to present claims with some real hope of success.

we regret very much, however, that the Government has not accepted our representations that in order to do full justice all claims for losses to property fairly arising out of the evacuation orders should be investigated and compensation allowed.

There are a considerable number of cases in which losses are still excluded from the terms of reference because the properties in question were not vested in the Custodian and loss was sustained before the appointment of the Custodian, either through forced sales, theft or vandalism, or the acts or omissions of other agencies.

We will continue to urge that more complete justice be done in respect to this class of claims and we plan to assist in the preparation of the necessary information, so that the cases of this group of claimants may be put before Parliament and the Government.

Nevertheless we do not think it would be in the interests of the Japanese Canadians that those who are entitled to
present their claims under the amended terms of reference should seek
to beycott the Commission on the ground that the terms of reference
are still not broad enough to cover all of those who in justice may
be thought to be entitled to compensation.

Indeed we urge all those who have suffered loss through sale by the Custodian or through destruction or theft of personal property, after the property was vested in the Custodian, to take advantage of the Commission and to present their fair claims as vigorously as they can.

Our view has been strengthened by the information that the test case taken in the Exchequer Court against the Crown in regard to the legal right of the Custodian to sell the property of Japanese Canadians under the various Orders-in-Council, has been dismissed.

It is our opinion based on the advice of the solicitors who represent the Japanese Canadians in these cases that there is little to be hoped for in the way of legal proceedings in the Courts and those who have based their hope on this means to secure compensation for losses must now abandon such hope.

It is the intention of the Co-operative Committee acting through and in co-operation with the National Japanese Canadian Citizens Association in the various provinces, to propose a plan whereby legal assistance in presenting the claims may be made available to those who may find such assistance necessary or desirable.

we shall shortly be issuing a further statement giving the details of this plan and setting out what steps should be taken by the Japanese Canadian claimants to present their claims to the Commissioner.



We have for acknowledgment receipt of your letter of July 31st.

We have to advise that Mr. Justice Bird has been out of town and we will endeavour to get in touch with him as soon as he returns and when we succeed in doing so. we will advise you.

Concerning the matter raised in your letter of the 31st ultimo, as to the estimated amount of time which we might be required to spend on matters relating to the enquiry, you will appreciate that it is extremely difficult to determine, without knowing how many cases will be involved. However, from the little information on hand, it would appear to us that one hundred full days might reasonably cover what would be required. Concerning the matter of contributions from the Japanese themselves, a little over a month ago we suggested to the Japanese Committee at Greenwood that they might suggest to some of the persons who will be receiving refunds through that Committee from this firm that they might be willing or desirous of assigning the refunds or a part thereof for the purpose of carrying on the proceedings before the Commissioner. However, we have received no response to the idea. We still have a fairly large quantity of money on hand, which is due to be refunded. We now have a number of refunds which we will be paying out in the next few days, but there will remain quite a number more. Possibly you might get some results by writing to Mr. K. Sato of Japanese Canadian Citizens' Association at Greenwood, B.C.

The labour case which I mentioned to you in my last letter as being involved in, is over the recent Industrial Conciliation and Arbitration Act passed in B. C. We were before the Court of Appeal yesterday and the day before arguing the question as to whether the Act created a Union into a juristic person and had occasion in argument to refer to several cases in which we noted that you had acted. With particular respect to the United Steel Workers' case, we noted that the Ontario Act was passed in 1943, the case was decided in 1943 and that in 1944 the Act was repealed. The Provision for a Labour Court in the Judicature Act was likewise repealed that year. We wondered whether, by any chance, the elimination of the labour courts was a result of an attack on their validity or whether it was only because of the fact that the Ontario Government decided to adopt and apply P.C. 1003. In the case in which we are acting, the "strikers" gave been convicted of a technical offence under the Act and fined \$1.00 and \$1.00 costs. We are taking a stated case to the Supreme Court and would not be at all surprised if we if we went to the Court of Appeal. One of the issues therefore, is whether the Board which is set up in the Act with wording very similar to that contained in the provisions of P.C. 1003 is constitutional. You will recall that in P.C. 1003 it is provided that where any proceedings are being taken in the Courts and certain questions of fact or law arise the proceedings are to be stayed and the questions referred to the Board whose decision shall be final and conclusive. We intend to attack the constitutional validity of these provisions on the ground that the Act purports to set up a Court with jurisdiction concurrent to the Supreme and County Courts and to appoint the judges thereof contrary to the provisions of Section 96 to 100 in the B. N. A. Act. Inasmuch as we understand that P.C. 1003 may still be the law in the Province of Ontario, we thought that perhaps you might be interested in this.

We noticed a reference in the local press today to the Japanese enquiry which suggested that Mr. Justice Bird would like to get the enquiry started before September 9th when the Court of Appeal sits in B. C. and, furthermore,

indicated that it might be his intention to start in the West and move East. We are doing our best to get in touch with him today and, if we possibly can, we will do our best to delay proceedings and, if at all possible, to start in Eastern Canada, taking this to be in accordance with your desires. We were interested to note that the Prime Minister had indicated that the reference for the enquiry might be broadened. In this connection we had an off-the-record talk with the Custodian of Japanese Property, the other day and he indicated in our conversation that he had urged Ottawa to broaden the terms of the reference. Needless to say, you wouldn't be able to use that as direct information in urging a broadening, but we thought it might be a useful piece of information for you to have in mind.



Re: Japanese Claims.

We appreciated receiving your letter of the 26th inst. reporting on your discussions with Messrs. Ilsley & Gibson. We were sorry to hear that they did not hold out a better prospect. However we shall await with interest the final outcome. Unfortunately we were unable to get in touch with Mr. Justice Bird before the long week-end. However, we will communicate with him at the earliest possible date.

Upon your suggestion the writer will endeavour to line up a Committee in B. C. to represent the Co-operative Committee and will report to you. It should be possible to do now that the holiday season is about passed. We would suggest however, that the Co-operative Committee write a letter care of the writer appointing the local committee its representative and outlining the tasks which it considers can be most usefully performed by it.

It has now been confirmed that, subject to unforseen difficulties, I will fly East on September 25th. I expect to arrive in Toronto in the early morning of the 26th and am writing today to the King Edward for reservations. I expect to go up to Ottawa on the night of the 27th or the day of the 28th to attend a meeting of the National Directors of the Co-operative Union of Canada from the 29th until the 3rd or 4th. I expect to return to Toronto on the 4th or 5th of October and to be in and about Toronto until the 10th.

Not having had any holiday for some time I have decided to take my wife along with me, and so far as possible want to keep the last week as far as possible a holiday. Accordingly I would prefer to meet with you and your

Committee on the 26th and 27th if possible. However, I am anxious to get fully briefed while we have the opportunity to meet together and will spend as much time at whatever time meets your convenience on the problem. If the hearings do actually get started on October 1st I may get a chance to look in on them. I also want to look in on the Canadian Congress of Labour meeting if I get an opportunity.

You will be interested to know perhaps that this past week I have been very much engaged acting for the United Steelworkers. Five of the Companies are suing the United Steelworkers of America and two of its locals for damages for unlawfully striking under Bill 39 and this week applied for an injunction against striking and picketting and a mandatory injunction to the Unions to call off the strike and to order the men back to work. The Companies are backed by the Canadian Manufacturers Association which is their bargaining agent. allege that as Bill 39 prohibits striking, despite the fact that it provides a severe penalty, an actionable tort is thereby created. It appears to me that this is one of the most sercous attacks on Unions which we have had in a long time. Judgment has been reserved on our application to set the Writ aside and also on the application for the injunction. I expect we will know the answer early this coming week. If we have the opportunity while I am in Toronto, I am looking forward to having a good chat with you and other persons interested on labour legislation matters.
