of the War Committee on September 22nd, 1943, and reported that the Department of Labour and the R.C.M. Police were unwilling to concur in the proposed recommendation of Defence Council for amendment of British Columbia Security Commission Order No.1, New Series.

It had been stated by the Minister of Labour that the amendment proposed would be an

impediment to the employment of Japanese in British Columbia and would be both unworkable and unenforceable under present conditions. It was suggested as an alternative that a zoning system would serve the same purpose more effectively. An explanatory note had been circulated.

- that while it was not intended to hinder the employment of Japanese, nevertheless, it was felt by Defence Council that the present system did not provide sufficiently effective control to satisfy security requirements.
- agreed that appropriate officials of the Department of Labour confer with the R.C.M. Police and the Chiefs of Staff, with a view to recommending agreed measures which would provide the required measure of security without involving the difficulties mentioned by the Minister of Labour.

Navy; construction of additional small craft

a statement of the Navy's small vessel requirements up to the end of the next fiscal year.

The programme recommended involved an estimated expenditure of \$6,265,400. Of this, \$500,000 would be expended during the present fiscal year; for this, funds were available in the 1943-44 estimates. The balance would be required during the fiscal year 1944-45. \$1\frac{1}{2}\$ million of the total amount involved would be employed for the hiring of small craft, and the balance for construction and purchase.
