

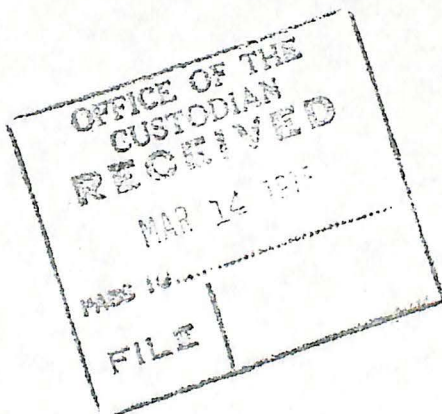

We received your letter of June 8th, and must apologize for not having replied to this sooner. This was due to the writer's absence and to the fact that before taking any steps, we wished to consult with our counsel, Mr. J.E. Brownlee, K.C.

We are sending you attached a list which shows the names of all those shareholders who live in enemy or enemy occupied countries, which list is complete to the best of our knowledge.

On this list we have shown the number of the old issue of \$25.00 par value shares, which were registered in the name of each shareholder. These shares, of course, are now out of existence, and we have shown also the number of Class 'A' shares, par value \$20.00 each; and Class 'B' Shares, par value \$5.00 each; which each shareholder received in the reallocation which was put into effect last year.

The basis of the exchange was the total par value. That is to say for instance; Andy Frigstad in Norway owned twenty-two \$25.00 par shares, or a total par value of \$550.00. In the reallocation he receives twenty-seven Class "A" shares at \$20.00 each- \$540.00; and two Class 'B' Shares at \$5.00 each- \$10.00; Total \$550.00; as one of the conditions of the reallocation was that in no case would more than four Class 'B' Shares be allotted to any one shareholder.

We are also sending you certificates as listed, prepared in your favour for the account of each of the different shareholders, with the exception of Mrs. Pichot in whose favour we issued certificates which were mailed to the Banque Canadienne Nationale, Montreal- and Olaf Kjelland, as these certificates have already been issued in your favor and were mailed to you in May this year.

In these two cases the old certificates were surrendered to us, and have been duly cancelled, but in the other cases the certificates are still outstanding, and so far as we know are in possession of the shareholders concerned.

The old certificates are not negotiable and our Transfer Agents and Stock Exchanges have been notified to that effect.

We trust you will approve the issue of these certificates to you, and that you will find all the information you require in the list, and will supply us with a warrant or request to us, to issue these certificates, so that we will be in a position to refer any further inquiry from any of these shareholders, to you.

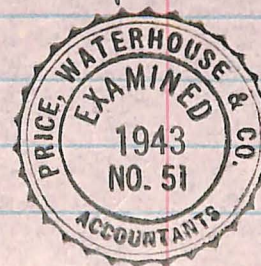
