Will you be kind enough to make arrangements with the "Green Cove Salteries Limited" to send me the sum of \$100.00, for ever since I have been arrested by the Royal Canadian Mounted Police I did not have any money.

According to the statement of A. H. Mathieu, assistant deputy custodian, I still have the sum of \$202.39 in your file No. 17794.

I have debts among my fellow internees amounting to approximately \$65.00 which was used to purchase such personal articles as tooth brush, tooth paste, handkerchief, tobaccos, etc.

I shall be very much obliged also if you will kindly send me the sum of \$25.00 per month without my further application.

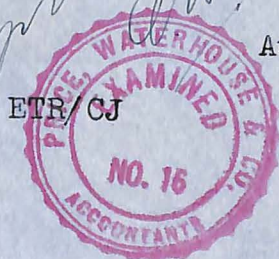


