

I refer to your letter dated the 24th instant, returning Forms "A" relating to the above claims.

Regarding the Custodian's claim against you in reference to Fujiya & Co., it is observed that you incorporated in Form "A" what appears to be the amount of an alleged counter claim. I wish to point out that any claim against an enemy within the meaning of the Regulations must be supported by a Statutory Declaration by the claimant. This Statutory Declaration must contain full and detailed particulars of the evidence by which it is proposed to prove the claim; and any documents which bear upon the matter or are tendered in support of the claim must be exhibited to the Declaration. I also draw your attention to the fact that under the Regulations, the claim of any person who fails to comply with the Custodian's requirements respecting the furnishing of information and documents and the manner of verification thereof is liable to be barred and extinguished.

As regards payment of the various claims against you, the Custodian is not willing that they remain in their present condition; and I am therefore directed to require payment without further delay. Presumably you received the goods in respect of which the claims are made and have sold or otherwise dealt with them. If you are not in the position to pay the whole amount, the Custodian will be prepared to consider some reasonable arrangement for payment by instalments; but this is entirely without prejudice to the Custodian's right to insist upon payment of the full amount forthwith. It is my duty to point out that, apart from the right of the Custodian to proceed in the Exchequer Court of Canada to enforce any claim against a debtor, by means of action or a registered certificate of indebtedness, the Regulations impose penalties for the omission or refusal to make any payment or to furnish required information and particulars.
