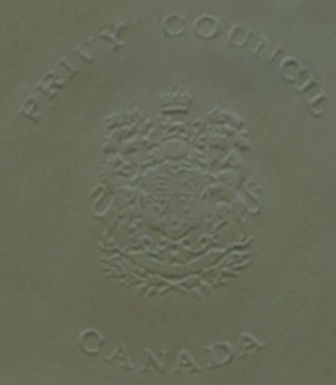

AT THE GOVERNMENT HOUSE AT OTTAWA  
Tuesday, the 31st day of March, 1942.

PRESENT:

HIS EXCELLENCY

THE GOVERNOR GENERAL IN COUNCIL:

WHEREAS Order in Council P.C. 1271,  
dated February 17th, 1942, provided for the  
formation of a Corps to be known as the  
Canadian Japanese Construction Corps to  
assist in the fullest possible utilization  
of the manpower of Canada in the furtherance  
of the war effort;

AND WHEREAS, pursuant to the recom-  
mendation of the British Columbia Security  
Commission, it has been decided that the  
formation of the Canadian Japanese Construction  
Corps should be deferred for the present;

NOW, THEREFORE, His Excellency the  
Governor General in Council, on the recom-  
mendation of the Minister of Labour and under  
the authority of the War Measures Act,  
Chapter 206, Revised Statutes of Canada 1927,  
is pleased to order and doth hereby order  
that the Canadian Japanese Construction Corps  
shall not be formed until and unless the  
Minister of Labour decides that the formation  
of the Corps will aid in the fullest possible  
utilization of the manpower of Canada in the  
furtherance of the war effort.
