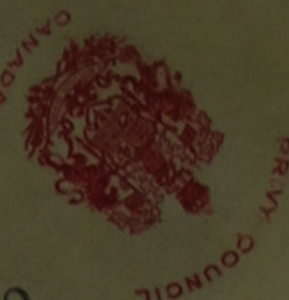

The Committee of the Privy Council have had before them a report dated 8th July, 1942, from the Minister of Labour, representing:-

1. That Order in Council dated April 1, 1942 (P.C. 2616) granted authority to charge to moneys allotted from the War Appropriation 1942-43 for the evacuation from the protected areas in British Columbia of persons of the Japanese race, any costs not in excess of \$75,000 incurred by the British Columbia Security Commission in acquiring and/or providing necessary year around housing accommodation in certain abandoned mining camp townsites such as Slocan, Kaslo, Sandon and Greenwood in the Province of British Columbia for considerable groups of Japanese persons evacuated as aforesaid and in reconditioning such of said housing as needs reconditioning;
2. That the aforementioned Commission has reported that the aforesaid housing and reconditioning will cost approximately \$30,000 more than originally estimated and have requested that said additional amount be made available for those purposes.

The Minister deems it advisable to grant the aforementioned request and, therefore, recommends that, under the authority of the War Measures Act, Chapter 206 of the Revised Statutes of Canada, 1927, authority be granted to charge costs incurred by the British Columbia Security Commission not in excess of \$30,000.00 additional to the amount authorized by Order in Council dated April 1, 1942, (P.C. 2616) in carrying out the purposes referred to in paragraph 1 above, to moneys allotted from the War Appropriation 1942-43 for the evacuation from the protected areas in the Province of British Columbia of persons of the Japanese race.

The Committee concur in the foregoing recommendation and submit the same for approval.
