The Committee of the Privy Council have had before them a report, dated 17th February, 1943, from the Minister of Labour, representing:-

1. That by Order in Council P.C. 3903 of May 11, 1942 the Minister of Labour was authorized to enter into an agreement with the Province of Ontario in respect of the movement, placement and employment of persons of the Japanese race moved from restricted areas of Canada to employment as labourers on sugar beet farms and other agricultural work in the Province of Ontario and for the expenditure of an amount not in excess of \$15,000.00 to provide necessary housing accommodation, policing and/or other care required in carrying out the aforesaid employment programme;

2. That an amount of \$20,000.00 additional to the amounts already authorized therefor will be required to pay for the costs of the housing accommodation and other care for persons of the Japanese race provided under the authority of the said Order in Council P.C. 3903 of May 11, 1942, and that it is necessary that the said amount be made available for such purpose.

The Committee, therefore, on the recommendation of the Minister of Labour, advise that authority be granted under the War Measures Act, Chapter 206, Revised Statutes of Canada, 1927, to charge the costs incurred in the housing, and care of persons of the Japanese race under the said agreement entered into by the Minister of Labour with the Province of Ontario under the authority of the said Order in Council P.C. 3903 of May 11, 1942, to the monies allotted to the Department of Labour from the War Appropriation 1942-43 not exceeding the sum of \$20,000.00 and that such sum be in addition to the amount authorized by Order in Council P.C. 3903 of May 11, 1942.
