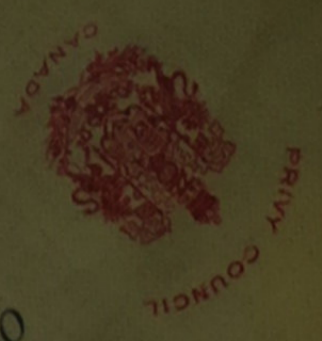

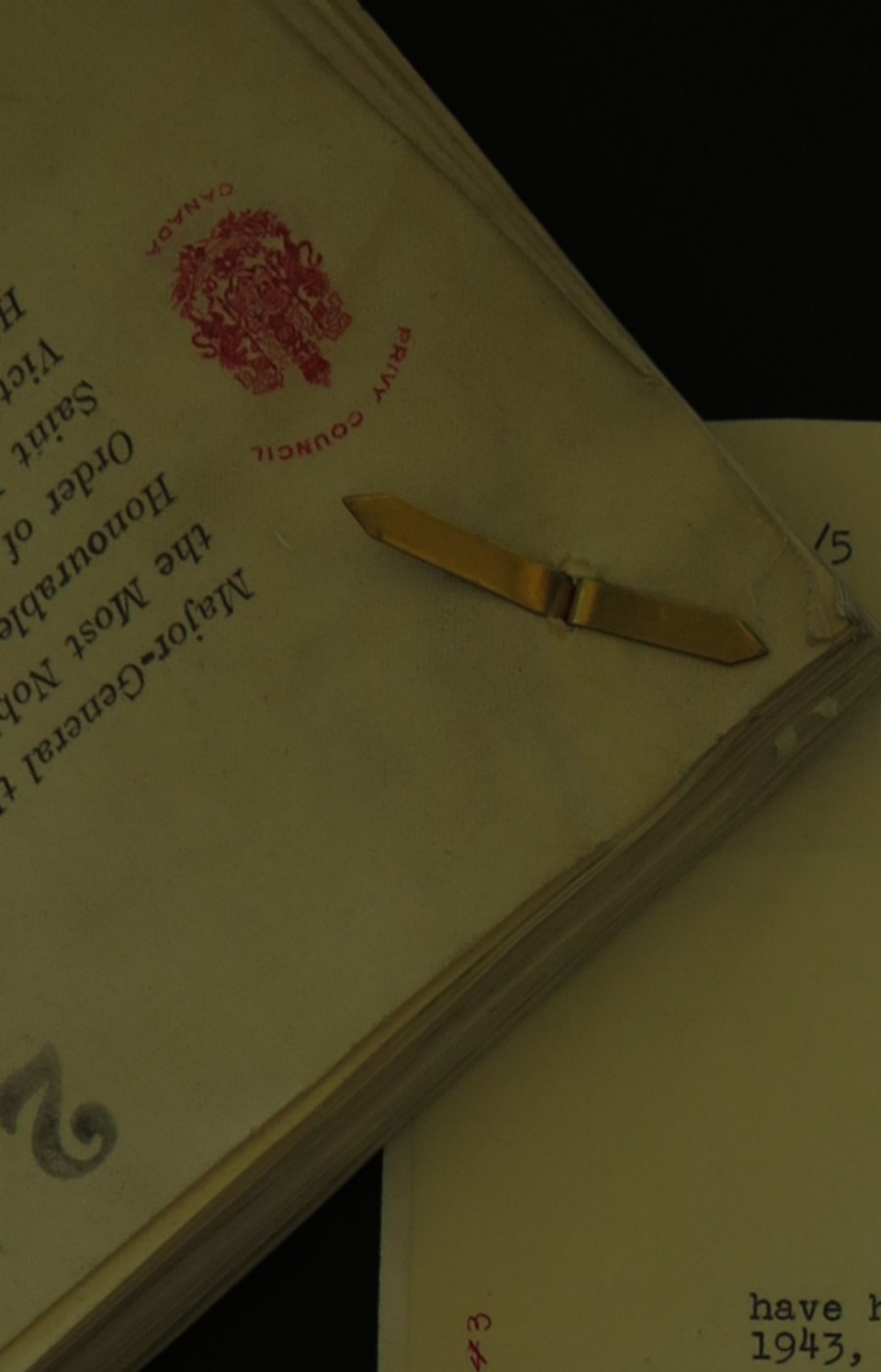

The Committee of the Privy Council have had before them a report, dated March 6th, 1943, from the Minister of Labour, with reference to Order in Council P.C. 946 of February 5, 1943, which authorizes the Minister of Labour, with the approval of the Governor General in Council, to acquire real property on behalf of His Majesty as required in the administration of the regulations governing the evacuation of Japanese from the Protected Areas of British Columbia and their placement elsewhere.

16th. Mar. 1943

The Minister observes that the Commissioner of Japanese Placement has recommended to him that Lot 4877, Kootenay District, British Columbia, be acquired on behalf of His Majesty at a purchase price of One Dollar (\$1.00) for the purpose of assuring to the Japanese settlement at Roseberry, B.C., its water supply which has its source on the said Lot.

The Committee, therefore, on the recommendation of the Minister of Labour, advise that under and by virtue of the powers conferred by the War Measures Act, Chapter 206, Revised Statutes of Canada, 1927, Your Excellency may be pleased to authorize the purchase by the Minister of Labour on behalf of His Majesty, of Lot 4877, Kootenay District, British Columbia, from the owner thereof, Zincton Mines Limited, at a price of One Dollar (\$1.00).
