MORIKICHI DOI, the claimant herein, being first duly sworn, testified as follows:

DIRECT EXAMINATION BY MR. BEST:

Q. Is that your signature (Indicating)?

A. Yes. That is mine.

Q. And was that form prepared upon your instructions? A. Yes.

Q. And you swear the contents of it are true?

A. Yes.

MR. BEST: I am submitting as Exhibit 1 the Personal Chattels Claim Form.

(PARTICULARS OF PERSONAL CHATTELS,
MARKED EXHIBIT NO.1)

Q. I understand that before evacuation you carried on a fishing business at Carlisle Cannery?

A. Yes.

Q. And that is near Prince Rupert?

A. Yes.

Q. And, you had been in the fishing business for some years? A. About 10 years.

Q. You are claiming for certain personal chattels and goods which were left behind at the time of evacuation. Is that right?

A. Yes.

Q. Yes. According to your claim these goods were left in your home near the Carlisle Cannery and locked up at the time you left. Is that correct?

A. Yes. They were left in the house, locked up and I handed the key to a friend.

1 MR. CHRISTIE: I tender as Exhibit 2 the
2 Analysis of Personal Property Claim.

3 (ANALYSIS OF PERSONAL PROPERTY CLAIM,
4 MARKED EXHIBIT NO.2)

5 MR. BEST: Q. When were you actually evacuated?

6 A. In March.

7 Q. In March of 1942? A. Yes. I think
8 it was 1942. I have forgotten.

9 Q. Well now, I think we had better pursue that
10 a little further. You actually left Prince Rupert
11 in March? A. Yes. I left Prince Rupert for
12 Vancouver in March.

13 Q. And from Vancouver to Slocan in May.
14 Is that correct? A. Yes.

15 Q. Well, then, this reference on your claim
16 that you moved from the Carlisle Cannery to Prince
17 Rupert in early October at the end of the Cohoe
18 season refers to the previous year, 1941?

19 A. Yes.

20 Q. So that you locked up these goods in
21 your house in Prince Rupert in March 1942 when you
22 left. Is that the date?

23 A. No. Those were locked up in the house
24 in October 1941 and then I went to Prince Rupert.

25 Q. Did you ever go back to the house after
26 October 1941? A. No.

27 Q. This house which you had at Carlisle
28 Cannery was actually owned by the Cannery but you
29 lived in it. Is that correct? A. Yes. That
30 belonged to the Cannery.



1 Q. So that is what is meant when they say that
2 the goods were left at the Carlisle Cannery, they
3 meant they were left in your house, that is, the
4 house which you rented from the Carlisle Cannery.
5 Is that correct? A. Yes.

6 Q. Well now, I believe that some of your goods
7 were shipped to you in Slocan? A. Yes.

8 Q. And you are now just claiming for the
9 balance of your goods. Is that right?

10 A. Yes.

11 Q. And I understand from your claim that on
12 November 2, 1942 the Custodian wrote you a letter
13 with a list of goods? A. Yes.

14 Q. And in this letter it was stated: "Will
15 you please confirm that these are all the chattels
16 you left in storage at the Cannery by signing one
17 copy and returning to us as soon as possible". Do
18 you remember that? A. That was so at the
19 time but afterwards when I had time to think it over
20 I remembered several things which were not on the list.

21 Q. I wanted to ask you for an explanation
22 later. Is that your signature? (Indicating)

23 A. Yes.

24 MR. BEST: I imagine that my friend will want to
25 put that in as an exhibit.

26 MR. CHRISTIE: I think perhaps it had better
27 go in as Exhibit 3. It is a list dated November 2,
28 1942, and contains an inventory of the chattels stored
29 at Carlisle Cannery, the Skeena River, B.C., and is

signed by the claimant.

MR. BEST: I suggest you attach the letter to it. I have a copy of it.

MR. CHRISTIE: There is the original. That letter is attached.

(INVENTORY, NOVEMBER 2, 1942, WITH LETTER ATTACHED, MARKED EXHIBIT NO.3)

MR. BEST: Q. You were explaining to us that at that time you thought those were all your goods and later you decided that you had made a mistake.

Is that correct? A. Yes. Even at that time I had an idea that it was not complete but I signed it and returned it anyway and afterwards I remembered other things.

Q. There are on this inventory a list of four boxes. There is no mention of what was in the boxes at all and I think on your claim form to which you have sworn you say that you signed on the assumption that the boxes and kit contained the articles which you now claim. I take it from that that you assumed that those four boxes contained all of the articles for which you are now claiming that are not specifically set forth. Is that right?

A. Yes. That is what I thought, that the things not specifically mentioned were probably contained in these four boxes.

Q. And that would include the gramophone and the record player and this Halibut fishing gear?

A. Yes.

1 Q. I take it that it was after you had signed
2 this list on November 2, 1942, that you were informed
3 that your record player was stolen by some person
4 in this naval party. Is that right?

5 A. I heard about that long before.

6 THE SUB-COMMISSIONER: He would hardly think the
7 skiff was in that box.

8 MR. BEST: Q. How about this little skiff for
9 which you are claiming, I believe, \$10.? You said it
10 was tied up at the side of your house when you left.
11 Did you just forget about it or what was the explanation?
12 Why did you not tell the Custodian at the time that you
13 had left the skiff there?

14 THE SUB-COMMISSIONER: I think the explanation
15 is that they sent him a form to sign and he signed it.

16 MR. BEST: Yes. The skiff could not be in the
17 box and the record player could not be in there. I think
18 surely he thought "Here is a form I have to sign"
19 and he signed it.

20 THE WITNESS: I must have overlooked it at the
21 time.

22 Q. Was this letter of November 2 from Mr.
23 Green to yourself translated to you?

24 A. It is most probably that somebody did at
25 the time. I have forgotten.

26 Q. Do you read any English at all?

27 A. I can read a little but not very well.

CROSS-EXAMINATION BY MR. CHRISTIE:

Q. I am producing a J.P. Form, dated March 28, 1942. Is that your signature (Indicating)?

A. Yes. That is my signature.

Q. Now, did you make up this list under the personal property there? A. Yes. It was made out according to my statement.

Q. I note that there is no skiff there or any rice or flour. Have you any explanation of that?

A. The reason it was not entered at that time, I suppose, was because I had forgotten to mention it.

MR. CHRISTIE: I am tendering the J.P. Form as Exhibit 4.

(J.P. FORM, MARKED EXHIBIT NO.4)

Q. Did you just lock these goods up in your cabin or did you appoint this company as your agent? I am speaking of prior to your evacuation.

A. No. I just locked the things up in the house and left.

Q. And left? A. Yes.

THE SUB-COMMISSIONER: Q. That was in the Fall of 1941? A. Yes.

Q. Did you do that every Fall when you finished fishing? A. No. That was the first time. Up until then I usually stayed there during the Winter, but this year my daughter was getting married in Prince Rupert, so I came out in October.

MR. CHRISTIE: Q. Did you ever have any goods shipped to you directly by the Carlisle Cannery



1 Subsequent to your evacuation?

2 A. No, not direct from the Cannery without
3 the Custodian's knowledge.

4 Q. Nothing direct from the Cannery?

5 A. Nothing direct from the Cannery.

6 Q. In respect of these Japanese records which
7 you estimated at \$70., and sold for 35 cents, how old
8 were these records?

9 A. They were bought over a period. The oldest
10 were about two years and the youngest were just possibly
11 a few months.

12 Q. Were any of them broken?

13 A. No. There is none broken.

14 Q. How old was this Halibut Fishing Gear?

15 A. Those were also bought at different times,
16 the older parts about two years or so and the newer
17 ones a year or so.

18 Q. What is the usual life of a fishing-gear?

19 How long does it last? A. Halibut is a sort

20 of sideline. It was before and after the other
21 seasons. This Halibut gear was in the form of lines,
22 not nets. Those can be used for four or five years
23 or more.

24 Q. They are good for four or five years?

25 A. Yes.

26 Q. Did you have more than one cross-cut saw?

27 A. You mean a big saw for cutting firewood?

28 Q. There is a crosscut saw with handles listed
29 and it says "Saw without handles," found under the

30



1 heading "Not accounted for." I was wondering whether
2 you had more than one cross-cut saw or whether you had
3 removed the handles. It seems odd that anybody should
4 remove handles. A. There was just one saw
5 with two handles.

6 Q. That is all, thank you.

7 MR. BEST: That is all; all right.

8
9
10 MR. CHRISTIE: I want to file as Exhibit 5 a Bill
11 of Lading dated October 7, 1943, and the goods listed
12 there were shipped to Vancouver from the Carlisle
13 Cannery. They were shipped to Mr. Doi, care of the
14 Custodian. It will be Exhibit 5.

15 (BILL OF LADING, OCTOBER 7, 1943, MARKED
16 EXHIBIT NO.5)

17 And, as Exhibit 6 I file the Personal Property
18 Summary.

19 (PERSONAL PROPERTY SUMMARY, MARKED EXHIBIT NO.6)

20 That concludes the exhibits, your honour.

21 It is submitted, your honour, that those articles
22 of personal property which were sold at auction were
23 sold at their fair market value.

24 It is submitted that the Custodian is not
25 responsible for those goods of which he had no record
26 and which were not sold by him.

27 It is submitted that the value of other goods
28 was exorbitant.

29 That concludes the defence.





This man signed a declaration to the Custodian on March 28, 1942. He was evacuated on May 4, 1942.

CHATELS: In his declaration he reported 10 boxes containing a gramophone, records, kitchen utensils, carpenters tools and 3 chairs left at Carlisle Cannery. On October 7, 1943, the Carlisle Cannery shipped to the Custodian warehouse in Vancouver, 8 pieces of effects identified as belonging to this man (See inventory 443) 4 of these pieces were sold at auction on 18/1/45 and the net proceeds of \$7.65 were credited to the account of this man. While the goods were being sorted, prior to the auction 3 boxes and 1 case were placed aside as being personal goods and appear in inventory 681. The case, presumably records was sold in Auction Sale Vancouver 58 for the net sum of \$0.28. No record can be found of the three cartons which appear on inventory 681, nor of the 50# keg listed on inventory 443. As will be noticed from the Chattel Schedule there are many items listed on the inventory of the Cannery which are not accounted for. No account can be found but it is possible that some may have been shipped direct by the Cannery. The inventory referred to as being from the Cannery was ~~probably taken by our Mr. Smith on his trip to the Canneries.~~
"supplied by Carlisle Cannery. Oct. 4/42".

He reported a Singer Sewing Machine, a box of kitchenware, and a trunk left with Dr. Kergin, Prince Rupert, B.C. On May 19, 1942 Geo. Rorie & Co., our agents at Prince Rupert, informed us that these articles plus a water tank and a stove had been shipped to Mr. DOI at his request.

He also reported a box of carpenters tools being held at Union Steamship Wharf, Vancouver. We assume these were picked up by DOI.

SPECIFIED

ARTICLES: Vessel - The records of the Japanese Fishing Vessel Disposal Committee show that this man was the owner of a vessel "M.D." which was sold to the Canadian Fishing Co. Ltd. and the net proceeds of \$49.50 were paid to K. MIWA for M.DOI on March 6, 1942. On April 7, 1942 we received the sum of \$150.00 from the Canadian Fishing Co. which appears to be an additional payment on this vessel. This was remitted to DOI on April 14, 1942.

CAMERA - The R.C.M.P. handed to this office a Kodak Camera surrendered by this man. This camera was mailed to him on April 2, 1947.

BONDS: He reported five \$100.00 War Savings Certificates, a \$25.00 War Savings Certificate and three \$5.00 War Savings Certificates, all in his wife's possession. These did not come under the control of this office.

NOTE - The funds standing to the credit of DOI, \$7.93 were sent to him on February 7, 1947. He returned the cheque on March 24, 1947 stating that the goods were sold without his permission and were worth more than that. A copy of his letter has been sent to Mr. Shears and the Department of Labour advised.

This file reveals no other property of any kind.
