THIS AGREEMENT made in duplicate this _____ day of December, A. D. 1942.

BETWEEN:

BRITISH COLUMBIA SECURITY COMMISSION, a Commission established by the Governor-General-in-Council under the powers conferred by the "War Measures Act", (hereinafter called the "Commission") of the First Part,

- and -

HIS MAJESTY THE KING in the right of the Province of Alberta, represented herein by the Honourable the Minister of Health (hereinafter called the "Province") of the Second Part.

WHEREAS the Commission on the _____ day of May, A. D. 1942, entered into an Agreement with the Province relating to the sending in to the Province of Alberta, persons of the Japanese race who are agriculture workers together with the wives and families of such Japanese

AND WHEREAS a number of Japanese families have, pursuant to the said Agreement, been established in the Province of Alberta.


AND WHEREAS under the terms of the said Agreement the Commission agreed that no members of the Japanese race for their descendents moved on its orders into the Province of Alberta will become

a charge on the said Province or on any city, town, village Municipal district or improvement district province patient for relief, medical services,

medicine or hospitalization or otherwise and further agreed that should any of such Japanese require hospitalization or medical care or dental care, and should they fail to pay for the same as required, the Commission would pay any amount Municipal district which the Province or any such city, town, village W**Municipality* Or Improvement District may incur for such treatment.

AND WHEREAS it is deemed desirable that in any cases

where any of the Japanese persons hereinbefore referred to are in need of food, clothing or shelter, such relief should



be granted and administered by the Board of Public Welfare constituted under the Eureau of Public Welfare Act being chapter 40 of the Statutes of Alberta, 1939, on the terms and conditions herein set out.

NOW THEREFORE THIS AGREEMENT WITNESSETH:

1. The Province agrees that an investigator employed by by the Bureau of Public Welfare will investigate any application by or on behalf of any such Japanese person for such relief /or full as aforesaid, namely, food, clothing and shelter and will make @ a recommendation to the Commission as to the amount of relief if any required.

2. The Commission agrees that it will forthwith notify the office of the Eureau of Public Welfare at Edmonton of its approval or otherwise, as the case may be, of such application with any changes in the recommendation which the Commission desires.


5. The Province agrees that the Bureau of Public Welfare will, upon receipt of the Commission's approval, furnish such relief so approved of to the applicants for same, which relief shall be continued until the Commission notifies the Board that the granting of such relief is no longer approved.

4. The Commission agrees that the Bureau, through its investigator, may in any case where an emergency exists, issue relief to the extent of \$5.00 without the approval of the Commission.

5. The Commission further agrees that it will at the end
of each month, or as soon thereafter as practicable, reimburse
the Province for all amounts paid by the said Bureau pursuant
to any of the terms of this Agreement during the said month.
6. The Commission will also pay to the Province at the

end of each month, or so soon thereafter as practicable, such or portion of salary portion xof xthat salary of the investigator employed by the

Bureau as is proportionate to the amount of time each month spent by the investigator in carrying out the terms of this Agreement and also any other amounts paid by the Province for any additional elerical assistance necessary to be employed by the said Bureau in carrying out the terms of this Agreement. 7.5 The Province agrees that the relief granted hereunder shall be as nearly as practicable on the same scale as in is ordinarily advanced to indigent persons in similar circumstances.

8. The Commission agrees that it will assume direct responsibility and expenses in connection with medical services, hospitalization, sanitarium treatment or institutional care required by any Tapanese persons brought to the Province pursuant to the Agreement hereinbefore referred to and dated the ______ day of May, A. D. 1942.

9. This Agreement may be terminated by either party giving to the other party thirty days notice in writing of its intention to terminate the Agreement at the end of such period.





I beg to acknowledge receipt of your letter of December 18th in which you bring to my attention the fact that this Commission is prepared to accept accounts for maintenance furnished to indigent Japanese in your Province where certain articles have been supplied which would ordinarily not be honoured by the Welfare Department of the Province of Alberta.

I can quite appreciate the position in which your Auditor finds himself inasmuch as your Welfare Workers are authorising expenditures that would not normally be acceptable if they were dealing with bona fide residents of Alberta.

In view of the fact that the problem of handling the evacuated Japanese is due to the exigencies of War and that the Department of External Affairs is endeavouring to obtain better treatment for the Canadian Nationals now in the hands of the Japanese, it is considered advisable to be a little more lenient with the persons of the Japanese race in Canada than might normally be the case with our own citizens.

I an, however, requesting our Supervisor for Alberta to co-operate with your Welfare Worker to see that such exceptions are kept to a minimum.





> Under Clause 6 of the Welfare Agreement with the Province of Alberta, dated December 1st, 1942, it is provided that "the Commission will also pay - portion of salary and travelling expenses of the Investigator employed by the Bureau as is proportionate to the amount of time spent by the Investigator in carrying out the terms of this Agreement -- "

I am attaching memorandum statement prepared by the Treasury Department showing that we have paid a total of \$842.49 for Mr. Wright's travelling expenses for the period from December 1st, 1942, to March 1944. No breakdown has been provided to show the amount of car expenses included. From personal knowledge, I know that they have only been charging us for actual out-of-pocket expenses in connection with the car,

The suggestion in the letter that the per mile reimbursement for car depreciation be established as from the beginning of our agreement with them to the total of approximately 25,000 miles or a total of \$500.00. The .02¢ per mile appears reasonable but it is doubtful as to whether we are obligated to pay same for the past period.

During the first four months of this year, our relief shows a reduction of \$12,257.00, as against the expenditures for similar period last year. At first glance this would appear that the Japanese located in this area, have become more self-supporting and settled in their work, but on the other hand, on checking over the record here, of funds withdrawn from the Custodian, we find that in the latter part of 1943, Japanese families in this area withdrew \$39,922.00 from funds held by the Custodian, and in the first four months of this year, they have withdrawn \$23,352.00. In other words, during the last nine months, \$63,274.00 has been withdrawn from Custodian funds by the Japanese people in this area. It is a well known fact that these people, when they have the money, are real spenders, and from the number of cars that are running around, and from the way they are living, it would indicate that they have purposely withdrawn this money, and spent it, in fear that the Government may seize it. In our opinion this is rather an interesting situation, and may have some bearing on our relief costs in the future.



Acknowledging your letter of January 11/44 addressed to Mr. A.E. Russell, Lethbridge, re Kanamata family.

From your letter I note that you have the facts fairly well in mind concerning this family. As you can see, they have very much taken everything into their own hands ever since they came to this project. Their moves have been concluded without consulting this office and everytime they feel that they want something that they are unable apparently to provide for themselves, they play up Mrs. Kanamata's sickness.

I visited this family on three different occasions this summer during the beet season and from my observations Mrs. Kanamata appeared to be quite able to hold up her end in this work. She hoed beets and topped them right along with the rest of her family.

This last move that this family has made to Taber was, according to their statement, for the purpose of securing more work than they could get in the Raymond district, but I find that the facts are that he is unable to get any work there this winter. Also the farm he has gone onto is being abandoned by the man who worked it last year, and there will be no beets grown on this land this summer unless some one else takes over this farm.

I did not refuse this family relief entirely but took into consideration the earnings they had last summer





and computed from that the time which I considered they. should be able to maintain themselves without assistance, and told them that they would have to do this for 'that period which, according to their earnings, should have been till the first of February this year. On my last visit on January 10/44 to see how they were getting along, I found that they did not have much food left and that their credit had run out in the grocery store, so I granted them relief from January 15/44.



Re: Mitsugu UCHIDA, #13509

Above mentioned is party who, as a result of accident with subsequent hospitalization and prolonged period of non-working, is now in need of relief.

I have examined the statement of earnings in consultation with the employerand find that his net earnings for the period April 13th to November 13th were \$327.65, all of which has been expended for maintenance of his family of five persons; that is himself, his wife and three children under 16 years. There is at the present time the sum of \$57.31 outstanding at Grocery Store after all payments that can be made have been made, and they are out of coal. I instructed the employer to procure coal to the value of about \$16.00 (4 tons), which will make out-standing liability at this time of about \$75.00. Arrangement will now have to be made for the maintenance of this family during the winter.

From the statement of the employer it would Seem that this man, prior to his accident, was a good worker and Would be able to make a summer living on the farm although it is granted it would be necessary to find winter employment for this man and his family for next winter if he were still here, as five persons cannot live off the earnings of two, if those earnings are from beet work only.

Please instruct me at once as to method of

handling this case.

I may say that I wrote the Provincial Secretary under date of Nov. 6th requesting direction in regard to the administration of relief as indicated by your letter covering Mr. MacNamara's letter on the subject, but as yet have had no reply.
