A meeting of the War Committee of the Cabinet was held in the Privy Council Chamber on Wednesday, September 22nd, at 3.00 p.m.

the fact that this matter had been brought attention of Mr. Churchill before the Quebec Conference began, and could have been taken into consideration in the planning of operations.

agreed that the Minister of National Defence be authorized to communicate further on this subject with the U.K. authorities if he considered such communication useful in forwarding the project.

Canadian Fire Fighter Corps

referred to the decision of the War Committee on this subject on September 15th, and submitted proposals made by the Minister of National War Services regarding the employment of the Canadian Fire Fighters Corps in the Canadian Army. These proposals had been circulated.

B.C. Security Commission; travel of Japanese in Canada

presented a recommendation from Defence Council, approved by the Chiefs of Staff, regarding travel of Japanese in Canada. Copies of this recommendation had been circulated.

It was recommended that B.C. Security Commission Order No.1, New Series, be amended to provide that persons of Japanese race in British Columbia must obtain an R.C.M. Police permit prior to travel, for any purpose whatsoever, a distance of more than five miles from their place of residence.

- External Affairs pointed out that the proposed amendment might affect the conditions of employment of Japanese in British Columbia.
- approved the recommendation of Defence Council, subject to the concurrence of the Department of Labour and the Department of Justice (R.C.M.P.).

Housing congestion at Halifax

External Affairs presented recommendations from the committee appointed by the War Committee on September 8th to report upon housing congestion at Halifax. An explanatory note had been circulated.

The committee had pointed out that accommodation for 3,000 to 4,000 additional workers would be required in Halifax in the near future, and that it would not be practicable to provide accommodation by additional new construction.

Accordingly, it was recommended that an emergency controller be appointed, with power to place restrictions on classes of people going into Halifax, and to establish a permit system for persons remaining in Halifax based on the essential requirements of the Services and the Department of Munitions and Supply.

of the emergency controller extend to the City of Halifax and Dartmouth, and to an area of ten miles from the city limits of Halifax. It was suggested that the person appointed should have similar qualifications to those possessed by the Wartime Administrator of Canadian Atlantic Ports.
