

THIS INDENTURE MADE THIS 1st DAY OF March,
in the year of our Lord one thousand nine hundred and forty-
four.

IN PURSUANCE OF THE "SHORT FORM OF DEEDS ACT"

BETWEEN:

THE HONOURABLE THE SECRETARY
OF STATE OF CANADA, ACTING IN
HIS CAPACITY AS CUSTODIAN UN-
DER THE REVISED REGULATIONS
RESPECTING TRADING WITH THE
ENEMY (1943)

(Hereinafter called the "Grantor")

OF THE FIRST PART

AND:

THE DIRECTOR, THE VETERANS'
LAND ACT

(Hereinafter called the "Grantee")

OF THE SECOND PART

WITNESSETH, that in consideration of the
sum of Seventeen Thousand Four Hundred and Fifty-two Dollars
(\$17,452.00) of the lawful money of Canada now paid by the
said Grantee to the said Grantor (the receipt whereof is hereby
acknowledged) the said Grantor, DOETH GRANT unto the said Grantee
and its assigns FOREVER:

ALL AND SINGULAR those certain parcels or tracts of land and
premises situate, lying and being in the Municipalities as
particularly described and set forth in the schedule hereunto
annexed and marked with the letter "A" together with all
buildings, fixtures, commons, ways, profits, privileges,
rights, easements and appurtenances to the said hereditaments
belonging, or with the same or any part thereof, held or en-
joyed or appurtenant thereto; and the estate, right, title,
interest, property, claim and demand of the said Grantor,
in, to or upon the said premises.

TO HAVE AND TO HOLD unto the said Grantee
and its assigns, to and for its and their sole and only use
forever; SUBJECT NEVERTHELESS to the reservations, limitations,
provisos and conditions expressed in the original grant thereof

from the Crown.

AND THE said Grantor releases to the Grantee all his claims upon the said lands.

THIS conveyance is in pursuance of the terms of an Indenture made the 27th day of October, A. D., 1943, between the parties hereto in respect of the lands hereinabove referred to and other lands mentioned in the said Indenture.

IN WITNESS WHEREOF the said Grantor acting in his capacity as Custodian under the Revised Regulations Respecting Trading With The Enemy (1943) has executed these presents by his Deputy on the day and year as above written.
