ALL AND SINGULAR those certain parcels or tracts of land and premises situate, lying and being in the Municipalities as particularly described and set forth in the schedule hereunto annexed and marked with the letter "A" together with all buildings, fixtures, commons, ways, profits, privileges, rights, easements and appurtenences to the said hereditaments belonging, or with the same or any part thereof, held or enjoyed or appurtenant themeto; and the estate, right, title, interest, property, claim and demand of the said Grantor, in, to or upon the said premises.

TO HAVE AND TO HOLD unto the said Grantee and its assigns, to end for its and their sole and only use forever; SUBJECT NEVERTHELESS to the reservations,

limitations, provisos and conditions expressed in the original grant thereof from the Crown.

AND the said Orantor releases to the Grantee all his claims upon the said lands.
