Re NOTICE OF DECREASE.

Remarks In view of the fact that Mr. Tonomura will be receiving old age security as of January 1, 1967, your old age assistance payments will be decreased accordingly. In the case of married couples the income and assets are always considered jointly. In the remaining ten months of your assistance year, that is, from January 1/67 to October 31/67 you will only receive \$1.7.50 in old age assistance. You will note from the attached summary sheet that we have taken 10/12 of your joint income during that period. At the end of your assistance year we will review your case and make any necessary adjustments. We are sorry for this adjustment but under the circumstances we have no other alternative.
