Your application for old age assistance is now complete, and provided there is no change in your circumstances, payments to you will be effective as of November 1, 1966 at the rate of \$ 75.00 a month, plus supplementary social allowance of \$

Your first cheque for \$ 75.00 covering the period from November 1st to 30th will be mailed to you at the end of this month.

Subsequent cheques will be mailed at the end of each month. We regret that you are not eligible for supplementary social allowance and health

Your health services identification card emitting you to health services from services as will be noted by the monthly figures shown in the Supp. Social Allowance column on the attached summary sheet.

Under the "needs test" approach to the payment of supplementary social allowance the pre-determined budget covers such items as food, clothing, household operation, misc. items, etc.

The only amounts permitted over and above this are those required for shelter & utilities. Kindly refer to the "supplementary information" section of the attached summary sheet which shows the amounts applicable for your case.

Please notify your local welfare office at 1530 West 8th Avenue, Vancouver 9, B.C. Telephone 731-5727 of any change in your financial circumstances, including the receipt of unemployment insurance. To ensure that your cheques are mailed to the proper address, advise your local welfare office immediately of any change of address. Please feel free to consult your local social welfare worker concerning any problem with which you may be needing help.

Your cheques must always be endorsed in your own handwriting. A copy of our summary sheet is enclosed showing our calculations. P.S. Your present rate of old age assistance will be decreased as of Jan. 1, 1967, as we note your husband will commence receiving old age security from that date. Yours sincerely,
