Dear Sir: Re: Your adopted daughter


I have written further to the Department of Citizenship and Immigration and regret that I am not able to get very far. The Department advises that nationals of Japan are still classified as enemy aliens and there is no provision for their admission to Canada under present regulations. Secondly, even if at some future date nationals of Japan are removed from the enemy alien category the only way in which your adopted daughter could enter Canada as a student would be when she is duly qualified to attend University of College conferring a degree. The Department further says since your daughter is only twelve or thirteen years old it is hardly likely that for some years to come she would be in a position to qualify as a student under the present regulations.

Frankly Mr. Sato, I do not think that much more can be done. You know that with respect to Asiatics generally, the Government always has had a restricted Immigration policy and despite what you or I might think I think you will agree that the great mass of public opinion in this country purports to that policy. An exception were made in your case, Every Chinese at present registered in Canada would be clamouring for the admission of an adopted daughter or an adopted son and I do not think that the Government will put itself in this position.

I enclose herewith my bill.




