Your letter of May 14, 1952 addressed to Messrs. Isuke & Mitsugu Yonemitsu has been referred to me for appropriate attention and reply.

I have enclosed herewith Applications for Release duly executed by Isuke Yonemitsu and Mitsugu Yonemitsu.

In support of the application I have also enclosed waiver of claim signed by Isuke Yonemitsu. In addition, I have also enclosed an affidavit executed by Isuke Yonemitsu outlining the conditions under which he permitted Toranosuke Emoto to locate his dwelling on the premises. According to the circumstances Toranosuke Emoto would have no valid claim to the dwelling.

As documentary evidence in support of the application for release to establish that Kyuyemon Yonemitsu, who was formerly the registered owner of the premises known as 3683 Peardonville Road, Abbotsford, B.C., is the same man as Eyuemon Yonemitsu who asserted the Power of Attorney dated March 13, 1952 in favour of Isuke and Mitsugu Yonemitsu, I have enclosed Certificate of Registration of Birth of the Province of British Columbia issued in the name of Mitsugu Yonemitsu, which gives Kyuyemon Yonemitsu as his father.

I trust that you will present this material and application to the Custodian for his consideration.
