The assignments are on the attached sheets.

The proposed schedule is to conduct meetings in homes in November and December to distribute information, stimulate interest and encourage discussion. Once there is sufficient community support, public meetings could be held during January and February. One of the important functions of the initial meetings is to assure community members that the Redress Committee sincerely wants to hear their views and is not trying to push any particular position.

At the November 4 Redress Committee meeting the following requests will be made:

1. A pool of speakers be organised to attend the meetings in private homes.
2. An updated "fact sheet" or information package be made available for distribution at the meetings.
