At the foot of this letter you will find a statement of the amount awarded to you by Mr. Justice Bird, the Commissioner appointed by the Government of Canada. You will also find a statement of the amount for which you are responsible to the Co-operative Committee on Japanese Canadians, which you retained to represent you, for services rendered (being 1% of your original claim, plus your proportionate share of additional expenses), together with a statement of what you have paid (if anything) and the balance to be deducted from your award in accordance with your agreement. The statement is based upon legal accounts which have been rendered to the Committee and have been approved as fair and reasonable by independent legal counsel, and upon the report of P. S. Ross & Sons ~~Ltd.~~, our accountants. The Government paid other necessary expenses incurred by the Committee in presenting your claim.

TO SECURE PROMPT PAYMENT YOU SHOULD:

1. Fill in your address on the Release which is enclosed, and sign the said Release in the presence of a witness who should then attend before a lawyer, Justice of the Peace, or Notary Public, to complete the Affidavit of Execution at the foot of the Release.
2. Sign the authority to deduct the balance of fees payable by you to the Co-operative Committee.
3. Return the completed Release and authority to the Co-operative Committee at 94 Homewood Ave., Apt. 28, Toronto, Ont., in the enclosed addressed envelope.

Payment of the balance due to you will then follow by cheque to you within a few weeks.

If you wish to make enquiries, you may get in touch with the legal counsel of the Committee listed for your convenience on the reverse side of this letter.

The Co-operative Committee thanks you for your co-operation, and wishes to assure you that it has done its utmost to present your case and to secure for you the best possible award in the circumstances.

In accordance with the instructions of Mr. F. Andrew Brewin, we have compiled, and attach hereto, a Statement of the Computation of Balances of Awards payable to Claimants, who had retained the Committee (acting in consultation with the National Japanese Canadian Citizens Association) to present their claims to the Custodian of Enemy Alien Property.

This submission is comprised of the following exhibits:

- A Summary of computation of balances of awards
- B Statement of computation of balances of awards payable to claimants
- C Retainer fees received on claims withdrawn
- D Retainer fees received which could not be related to claims withdrawn or awards
- E Adjustments relating to computation of ratio of total of additional assessments to total of awards.

The following comments on the preparation and computation of the statement are submitted for your information and guidance when giving approval to, or making adjustment of, the balances shown as payable to the respective claimants.

Case numbers, names and amounts of awards listed in the statement (Exhibit B) have been taken from and are in the same sequence as that employed in the Statement of Recommendations for payment of Awards compiled by the Commissioner, the Honourable Mr. Justice Henry I. Bird.

Case numbers that had been circled in red pencil on the copy of the award statement supplied to us have been excluded as we understand these cases were not represented by the Committee.

Claimants from whom retainer fees were received but whose cases were not included, in so far as we could determine, in the Commissioner's statement of awards are shown in Exhibits C and D. Explanation of headings in the Statement, Exhibit B, are as follows:

Retainer fee - In the majority of instances the 1% charge is the amount stated in the retainer forms filed with the Committee by the claimants; the remainder represent 1% of the net amount of individual claims reported to us by Mr. R. J. McMaster of Vancouver.

Additional assessment - The total of this charge represents the difference between the total of the 1% retainer fee, and the aggregate of legal and other costs which were estimated by Mr. Brewin at \$100,000.00 for the purpose of determining what additional assessment should be charged to the claimants in respect of such expenses.

Additional assessment computation - The amount chargeable to each claimant is based on the ratio of (A) the total of the additional assessment required to (B) the total of awards, which ratio was applied to the award of each claimant.

Particulars of the computation will be found in Exhibit E.

Award - Amount shown on the statement of awards recommended by the Commissioner.

Amount payable - The amount of the award after deducting therefrom the "balance recoverable". The latter is the total of the retainer fee and additional assessment, less payments received on account of such charges from the respective claimants.

Certain adjustments were made when determining the percentage to be applied to the awards for the purpose of prorating the additional assessment, details of which are given in Exhibit E. These adjustments arose through suggestions made by Mr. McMaster that in certain cases, the 1% retainer fee charged to or the amount paid therefor by claimants might be considered by the Committee as in full settlement of all costs, being in effect on compassionate grounds. In other instances, because of special circumstances, the total of the costs chargeable to the claimant will have to be determined subsequent to the present computation.

In the event that the Committee decides to approve the charges to the claimants for additional assessment as computed herein, the total of the costs recovered by the Committee will amount to \$100,000.00. In addition, however, the Committee has received retainer fees aggregating \$417.46 in respect of claims withdrawn or claims that we were unable to relate to cases listed in the Commissioner's award statement, which are reflected in Exhibits C and D respectively.

We trust the foregoing and the attached exhibits present all the information and explanations you presently require but shall be pleased to furnish any additional assistance you may deem necessary.
