GREETINGS AND COMMISERATIONS!

The Petition of the undersigned humbly sheweth:

1. That your Petitioners are all of the full age of 16 years and are said to be of sound mind.
2. The allegations herein are true in substance and in fact to the best of our knowledge, information and belief and we believe anything and everything.
3. By, under, upon and with the advice of no one except ourselves, it is considered necessary, essential and desirable to bring to the attention of our Associates and all others whom these presents may concern, information hereinafter set forth, such action on our part being, as we verily believe, in the interests of justice, fair play and the general welfare of humanity.
4. Notice duly furnished, communicated and served, indicating that certain awards, rewards, prizes or tokens are to be issued to and bestowed upon certain fellow workers presently and supposedly engaged in the fulfillment of lawful orders, is hereby acknowledged.
5. Prior to the allotment or allocation of these tangible gifts to persons well known to all present, we each, for ourselves, on our own behalf and no one else in particular, desire to register and impart information that in our opinion should not be overlooked, disregarded or erased, but on the contrary should be carefully considered by all, individually and collectively.
6. The information referred to in the foregoing paragraph may be

described in the following words and form, that is to say:

On or about the 30th day of April, in the year of our Lord one thousand nine hundred and forty-five, at premises known as DeLuxe Bowling Centre Limited, situate on Hastings and Homer Streets in the City of Vancouver, in the Province of British Columbia, a group of players referred to as Custodian's League, participated in, played or otherwise engaged in a game of bowls on Alleys Nos. 3 and 4, at the hour of 4:30 o'clock in the afternoon.
