My dear Mac

As the successful conclusion of the European war brings much of the work of British Security Coordination to an end, I feel I should like to let you know how much I appreciate your very substantial contribution to our joint effort.

Our indebtedness to you dates back to the early days of the war when, as Counsel to the Canadian Custodian, you frequently went considerably out of your way to do us favours. Friendly co-operation such as we received from you did much to smooth the path of this organization when the going was more difficult than it is now. In September 1941, when we needed a man with considerable organizing and administrative abilities, we were very pleased to get you to undertake a full-time job for us, and I need hardly tell you how much we appreciated the fine work you did in the succeeding months.

It was a substantial loss to British Security Coordination when, early in 1942, the Under Secretary of State requested your return to Canada on the undeniable grounds that you were indispensable to the Custodian's office. However, we were lucky that even after we lost your full time services we were able to call on you from time to time for special favours that no one else could perform.
