

I beg to acknowledge receipt of your letter of the 6th instant re the birth of MIYOKO KAWAKAMI, now known as ASANUMA and would inform you that upon reference to our files it would appear that in 1931 we had correspondence with our District Registrar upon this matter although we have no trace of the letter, a copy of which you forwarded. However, we did inform our District Registrar that the surname on this birth registration could only be changed if a regular adoption had been put through the Courts. 
