


Dear Kit:

Dear Mr. Justice Norris,

I promised sometime ago to let you know how arrangements for entertaining the Japanese students were progressing. It turned out, in the end, that only two of the students going to Japan lived in Vancouver and could board a Japanese student. And yours was the only additional offer of hospitality which we received.

Subsequently, the Koerner Foundation offered to pay the residence fees for all the students for the whole period. We decided, therefore, to put them in the University residences, but to try to arrange entertainment for them at the weekends. For two or three weekends they will be taken on trips all together, but for the long weekend July 1-3, and for Saturday and Sunday, July 23, 24, we are hoping to board them out in private homes. I wonder if it would be possible for you to take a student for either, or both, of these weekends? I enclose a list of the students; you will see that one of them is a third year Law student, who, I am sure, would be delighted to have the opportunity of staying with you. *(or students)*

You also asked me to let you know about the travel fund. It has been established under the name Japan Student Exchange Fund and I should, of course, be grateful for any donation.



Dear Sir:-

I received your circular letter of 16th December with reference to entertaining a Japanese student during the summer.

I live at Pitt Meadows and go in and out every day except Sundays and sometimes except Saturdays. I have ample room in my house and will be glad to put a student up. He could come into town with me in the morning and go out when I go out in the evening. I would be willing to put him up for the whole six weeks. He would, however, to some extent have to fend for himself as I get my own breakfast and have lunch in town. Sometimes I have my dinner in town and sometimes I get it for myself at home. I will be glad that he should have dinner with me when I have dinner in town and would look after him for his evening meal when I am at home. I have no housekeeper but a woman comes in every day to wash dishes, clean the house, make beds and do the washing. There is a bus service into town in case he wanted to come in at times I was not driving in.

I thought it best to write you rather than fill in the form you sent because of the peculiar circumstances of my case.

I have an excellent library and the house is extremely comfortable. I would see, of course, that he got around and generally was looked after.

I suggest that you discuss the matter with my son, John, who is an Assistant Professor of History at the University. He will explain to you any details



To the Members of the Japan Society. 16th December, 1959.

The University of British Columbia has for a long time maintained good relations with Keio University in Tokyo. We have regularly been making an annual student exchange, and many other Keio graduates have come to do post-graduate work at U.B.C. This year Keio has proposed, and we have decided to try to co-operate with, a summer exchange of students.

The idea is that five Japanese students would come to Vancouver and be given free accommodation, board and entertainment by a Canadian family for the six weeks of the U.B.C. Summer Session. In return five Canadian students (possibly, and indeed preferably, from the same homes) would be boarded and entertained with an English-speaking Japanese family in Tokyo for the same period.

As soon as the new term begins at U.B.C. this scheme will be advertised among the students. Meanwhile, it would be very helpful to know whether any members of the Japan Society would be willing to entertain a student for all or part of the six weeks, 27th June to 6th August; also whether there is any possibility of receiving donations from members of the Society to finance the boat passages of both the Canadian and Japanese students. If some such financial support were available, the value of the scheme would be considerably enhanced.

I would be grateful, should you be able to help in any way, if you would return the attached form to me. Would you also, please, ask any U.B.C. student who might be interested in going to Japan to contact me at the University.
