Dear Sirs and Mesdames:

The Standard of Housing Sub-Committee have held one meeting and beg to submit the following report:

The necessary authority to establish such a standard is already included in the City Charter and reads as follows:

"For fixing standards of fitness for human habitation to which all dwellings shall conform; for requiring the owners of dwellings to make the same conform to any of such standards; for prohibiting the use of such dwellings which do not conform to any standard so fixed; for governing and regulating persons in the use and occupancy of dwellings and for appointing inspectors for the enforcement of the By-law."

The Committee is of the opinion that no very definite improvement in existing accommodation can be accomplished until a standard is established by By-Law not only for existing dwellings but for new dwellings also. Persons must no longer be permitted to erect sub-standard dwellings that tend to develop slums and create unsatisfactory health and social conditions. Where persons are financially unable to erect satisfactory dwellings for themselves, Government assistance must be forthcoming or provision made by the erection of low rental housing schemes.

The Committee have examined the City of Toronto Standard of Housing By-Law and the reports of improvements carried out through the application of this ordinance, but such improvements refer only to certain types of dwellings in blighted areas, this being the purpose for which the Toronto By-Law was originally designed.

There are several By-Laws relating to the various types of housing accommodation and these are often at variance with one another; a Standard of Housing By-Law should synchronize these differences.

The Committee is aware that a Standard of Housing By-Law has already been drafted, but in their opinion it is not sufficiently wide in its scope to include all types of housing accommodation since such a standard should apply to single, duplex and apartment dwellings, lodging and rooming houses.

The Committee will, with the approval of the Major Committee endeavour to draft the main principles of a Standard of Housing By-Law to embrace all types of dwellings with particular reference to lodging and rooming houses and ordinary rented premises.

If a proper standard of housing is established, people must be taught to respect the property of the landlord, and not wreck it as some do to-day, and also to keep the premises and the neighborhood clean and tidy; in fact all persons must be stimulated to take a keener and more public interest in the housing accommodation and environment of the whole community.

Dear Fellow Commissioner:

Owing to the large number of items on the agenda at the last two meetings of the Commission, it was not possible to have the enclosed Report read, therefore at the last meeting a resolution directed that the report be typed and sent out to Commission members.

I trust that you will find an opportunity to read the report. A supplementary or second part dealing both with general housing, as discussed at the recent San Francisco Planners' Convention, and also with the problem of "Defence Housing" is just about complete, and will be ready for presentation at a subsequent meeting of the Commission.

An evening paper of yesterday (February 26th) carried a prominent front-page caption over the name of Bruce Hutchison as follows: "Must Find Homes for 200,000 War Workers". In this article Mr. Hutchison gives some startling information. He says, for example, that: "The war boom did not produce new houses, and today vacancies in homes in the country at large are under one per cent (The normal vacancy ratio is five per cent) Up to now on this phase of the war problem it (the Government) does not appear to have moved at all. The whole thing seems to have been overlooked."

As you realize the agencies in Vancouver interested in housing have been very active in attempting to bring this problem before the Federal Government and realize that in all owing housing needs to come very near to a danger point, we are jeopardizing much more than an efficient war effort.

Mr. Hutchison also says: "For it is obvious that factories cannot produce without workers and that workers cannot work without homes."

Further comment is not necessary.

Origin

In its annual report for the year 1942 the Town Planning Commission asked the City Council to consider the appointment of a special committee on low cost housing to include interested civic bodies.

Committee Appointed

This Committee comprising Aldermen Buscombe, Corey and Greyell and the Secretary for Zoning Matters was appointed on February 15th, 1942. The Committee met on several occasions and to clarify its position made the following recommendation to Council which was adopted May 17th, 1943:

"That the Special Committee on Low Cost Housing be re-named the Post War Housing Committee, and that it be given authority to add to its membership representatives of such civic bodies or citizens as may be interested in the post-war housing problem, and that the Committee be further authorized to enquire and report from time to time upon what steps are being taken by the Dominion and Provincial Governments and other Canadian Cities with regard to post-war housing schemes and to endeavour to formulate post-war housing plans for the City of Vancouver."

"And further the suggestion of the Town Planning Commission, that the powers of the Committee be made wide enough to embrace all phases of post-war housing, to be concurrent in."

Action Delayed

As the problem of housing is national in its character the Dominion Government appointed a special committee (Quintis Committee) to examine and report on the whole situation. Subsequently, Vancouver and all large cities have awaited the findings of this group and further action by the Dominion Government. In the meantime the committee was divided into the following sub-committees; only two of those have been able to make any progress. The committees were, Publicity, Finance, New Areas, Construction, Rehabilitation, Standard of Housing. The last two submit the following reports on their work.

Rehabilitation Committee

This committee met on several occasions and considered the problems of housing rehabilitation from many angles. Discussions were held with the Corporation Counsel regarding the powers of the City to enter this particular field and as already mentioned, certain Charter Amendments were found to be necessary. Some study was given to two city blocks as an example, and such details obtained as to occupancy, ownership, and assessed value, but apparently little can be accomplished under the National Housing Act unless such schemes are primarily undertaken by a Limited Dividend Housing Corporation or an insurance company.

Dear Mr. Harrison:

Sorry I shall not be at the Housing Committee meeting called for tomorrow at 2 o'clock. This time conflicts with my lectures at the University. I regret missing the opportunity of meeting Air Vice-Marshall L. F. Stevenson.

This particular meeting is a special one I take it. I do hope, however, that at an early date a regular meeting of our committee will be called. There are several important matters which its members should consider.

May I take this opportunity of voicing my personal satisfaction that, arising out of some of our work, and more particularly perhaps as a result of our last meeting, the most important amendment to the City Charter dealing with the expropriatory powers of the Council has been included in the List of Charter amendments soon to be considered in the Provincial House.

This amendment is basic to sound city management. Without it we could do little to deal with the problem of our blighted and Slum areas which at the present time make such an extravagant demand on city finances, to say nothing of their demoralizing effect on the health and morals of many worthy citizens.

Dear Fellow Members:

The duties of the Post War Housing Committee as outlined by the City Council are in part as follows:-

"To add to it's membership representatives of such civic bodies or citizens as may be interested in the Post War Housing problem---to enquire and report from time to time upon what steps are being taken by the Dominion and Provincial Governments and other Canadian cities with regard to Post War Housing schemes and to endeavour to formulate Post War Housing plans for the City of Vancouver."

We have held a few meetings mainly for the purpose of hearing reports and the Secretary has continued to supply us with all the available information emanating from Ottawa, but beyond this we have accomplished practically nothing.

X
With the return of members of the armed forces to civil life certain aspects of the Post War period have in a sense moved forward into the present situation, and the problem of housing these men and their families should, in my opinion, receive our serious consideration. Although the Post War Housing Committee represents a cross section of the community it is understood a new committee has been appointed to look into this particular problem. It seems unfortunate that an attempt should be made to deal separately with any phase of the Housing problem and such action can only lead to confusion.

With the development of Housing Schemes both in Montreal and Toronto and considering the press reports that Housing Legislation will be brought down almost immediately, I feel that we should meet as soon as possible to discuss the whole situation or disband, since to date we have served no useful purpose.

Dear Sirs:

My association with the Council of Social Agencies has given me a clear insight into housing conditions in Vancouver and as a member of the Post War Housing Committee I feel the latter organization should take a leading part in an endeavour to advance what might be termed "Post War Housing Legislation" in such a manner that it can be applied to the present crisis particularly in relation to low-cost housing.

As you are aware it has been stated in the House of Commons by Mr. Illesley that the Government is prepared to lend the sum of \$2,000,000.00 to a group in Montreal for the purpose of erecting a low-rental housing scheme and is prepared to assist other cities in a similar manner.

Housing conditions for persons in the low income brackets are just as acute in Vancouver as in any Eastern city and the enclosed copy of the National Housing Registry's report for May gives interesting details of local problems particularly in regard to those gallant men who volunteered for overseas service and are now returning to civil life.

I would ask therefore with the Chairman's permission that a meeting of the Post War Housing Committee be called for Tuesday, June 27th, at 2 P.M. in order that we may discuss the question of obtaining Federal assistance at the present time along the lines already given in the City of Montreal.
