couver Court Registry with the original testament, written by Lee See Yip, also known as Lee Gee, reads:

"I, Lee Gee, otherwise known as Lee See Yip, native of Tung Hung, Village of Toy Sun District, Dwang Tung, came to Wancouver, B.C., over 30 years ago, a laundry worker now residing at 1624 Fourth Avenue West, acting as agent for the Loyal Laundry to receive and deliver laundry. "Now, as I grow old, my lungs are weak; it is hard to breathe; I fear that after my death no one will look after my affairs. Therefore, I make this last will.

"I give to my son, Lee Shir

my affairs. Therefore, I make this last will.

"I give to my son, Lee Shir Lum, now residing at Tung Hung Village, District of Toy Sun, Kwang Tung, after my death all my real and personal property and money due me from anyone after my inneral expenses are paid.

"I appoint my brother, Lee Dot, other wise known as Lee Thick Yip, now residing at 299 Pender Street East, Vancouver, to administer my estate and to execute my will.

"This is my will.

"(My own signature)."

Two Chinese witnessed the document, which has been filed by Lee Dot for probate.

The estate consists of cash in the bank and a \$50 Victory bond.
