New MORE BROKER SUSPECTED

BOOKS SEIZED IN THREE OFFICES

MR. SOLLOWAY PROMISES "PROTECTION"

WINNIPEG, Jan. 13.—(UPI)—Under instructions from the office of the Manitoba Broadcast and Publishing Company, two firms of auditors are investigating the books of the Winnipeg office of the Solloway Mills Ltd., lumber firm.

THE Vancouver Sun understands that exposures of a startling nature will follow the investigation of the Alberta government into recent stock market operations.

These investigations have been proceeding for two months and the result probably will mean the rejection of the application of a large brokerage firm for a new membership of the Vancouver Stock Exchange.

Thousands of people have lost their all. They have been "cleaned out" by manipulators.

FIRM SUSPENDED IN CALGARY

It is known that one firm has already been suspended in Calgary. This firm sold short about 100,000 shares of popular trading stocks in Calgary and could neither cover nor deliver.

Solloway Mills are trading in Calgary and all other markets and announce that they opened a new office in Lethbridge today.

The charge against Mr. Solloway and Mr. Mills apparently is that they used their nation-wide chain of forty-five brokerage houses to influence the buying and selling of all stocks on Canadian exchanges.

The official committee for charges of conspiracy laid against Mr. J. W. C. Miller and Mr. Harry M. Miller is as follows:

"That W. H. Johnson, of Victoria, B.C., did between the first day of 1929 and the 1st day of December, 1929, at Calgary, in the Province of Alberta, and in other Canadian municipalities with Harry M. Miller, L. E. Miller and others other persons, to wit, Solloway Mills Ltd., and as such were to the agents managing the establishment of the Solloway Mills Company Ltd., in the city of Calgary, etc., or the purpose of purchasing shares."

This charge has been denied, and Mr. Solloway has denied ever having been in contact with his office in order to aid that government committee.

In addition to the charges brought against Johnson, J. W. C. Miller is accused that the books of their other brokerage offices in other cities have been tampered with.

One of the firms in question is well known in Vancouver with some 2000 men.

MYSTERY BATTLE SCENE AT HOTEL

Rooms 201 at the Hotel Vancouver is today the scene of a mystery battle. J. W. C. Miller, who until recently was president of the hotel, has been unable to complete his account of the fight which took place in his office, and authorities were unable to find a plausible explanation.

COLD TAKES LIVES

Wintry Blast Sweeps South to Mexican Border

WHILE Vancouver thermometers this morning were recording a new low temperature record for the winter, reports from Pacific Coast and mid-western cities of the United States told of the loss of at least six lives due to the week-end blizzard which reached south to the Mexican border.

On the Canadian prairies the cold weather still continues but those which ruled last night were the lowest since the winter began, with 24 degrees below zero. In northern Manitoba the temperature rose to zero. Medicine Hat, with 16 below, was the coldest place in Alberta.

At 8 o'clock this morning the official reading in Vancouver was 12 degrees below zero compared with 14.5 yesterday. The official record of Fraser River Report, Sunday night and this morning, was recording 24 degrees above zero; 22 was 22 below at Prince George.

The temperature is rising over northern B.C. and colder weather may again descend again. The weather report reads:

SCORE DIE ON NAVAL TUG

125-MILE GALE AT EASTBOURNE

LONDON ALMOST ISOLATED

ONDON, Jan. 13.—Thirty-five persons lost their lives in a terrific storm which swept England Sunday night.

Twenty-three of the victims were members of the crew of H.M.S. tug St. Genny, which sank during the night 30 miles north of Ushant Light.

Only five men were rescued from the 42-ton vessel, which was en route to Gibraltar for service with the Atlantic fleet. The tug belonged to a flotilla for target service.

There were at least twelve deaths on land.

The wind reached a velocity of 125 miles an hour at Eastbourne and more than 100 miles an hour at other places.

ANOTHER BLOW APPROACHING

It subsided early today with as much suddenness as it had appeared earlier.

Falling trees were responsible for most of the casualties on land and for widespread cutting of telephone and telegraph lines and interruption of railway and highway traffic.

London was almost isolated as far as wire communications with other large centres was concerned.

SCENES OF DESOLATION

ON ALL sides today could be seen scenes which were the result of the gale. Trees and poles were uprooted and twisted, houses were destroyed, and streets were littered with debris. In London, where business and trade were suspended, the gale was experienced from the Atlantic and an early morning gale which struck the city.

Other scenes were seen with the winds blowing in the Channel, where a freighter had lost a rough and dangerous cargo.

A woman was killed and four people were badly hurt in Northumbria by a lightning bolt.

MIGHTY BATTLE SCENE AT HOTEL
