In his statement to the Custodian, the above noted Internee declared that he owned three (3) \$10.00 War Savings Certificates, which were left in the care of his mother, Mrs. Sei Goshi. These Certificates were delivered to the Custodian on December 2, 1942, and, at the request of the Internee, were forwarded to the Registrar, War Savings Certificates, for their redemption on February 19, 1943. The proceeds of the surrender value of these Certificates, amounting to \$24.16, were forwarded to Sueki Goshi at the Camp on March 9, 1943.

No property interests, other than the above-mentioned, are found on this file.
