Under date of March 18th, 1942, MACHIDA declared that he had no property of any kind whatsoever in any protected area of British Columbia.

NOTE:

The file indicates that he and his uncle, Denkichi MACHIDA, now deceased, had an option agreement covering Lots 9 and 10, Block 40, District Lot 196, Vancouver, B.C. Subsequently Denkichi MACHIDA claimed that he was entitled to title to the property as he had paid the purchase money and by Quit Claim Deed Takeyoshi MACHIDA dated Feb. 20/1943 recognized Denkichi MACHIDA claim and released all interest in the property. The Quit Claim Deed was delivered to Accounting Department for safe keeping June 17/1943 as per evidence on file.

None is revealed on the file.


LIABILITIES:


