GENERAL SUMMARY

Re: TADA, Iwajiro - Reg. No. 01619.

On November 8th. 1943, we received a cheque in the amount of \$456.97 from the Sun Life Assurance Co. being maturity value of life insurance policy of the above. This cheque was forwarded to him, at his request, on December 10, 1943.

On January 29, 1944, we received from the B. C. Security a cheque for \$447.77 to be credited to the account of Iwajiro TADA. Though the Japanese was then on maintenance, the B. C. S. C. asked us, in June 1945, that the money be held for rehabilitation purposes. Since, then, the Japanese has appeared on a list of repatriates, but to date, has not left Canada.

As it does not appear probable that he will return to Japan, we are writing the Department of Labour to ask if the money may now be sent.
