Z. Tabata has no other accounts and possesses no investments of any kind except an insurance policy with the Sun Life for \$1000. which he has carried for seven years. He has no car and owns no property or other assets in Canada, the United States or elsewhere. Subject claims to be free from debt. He has no war savings certificates or Victory bonds.

No property interests, other than those mentioned, appear on this file.


