




In a statement to the Custodian, dated October 15, 1942, Masaharu Miyasaki declared no assets or liabilities.

On July 21, 1943, the B. C. Security Commission forwarded to this office their cheque, amounting to \$6.50, being a refund of Miyasaki's transportation fare from Salmon Bay to Vancouver, B. C. These funds were credited to the account of this Japanese with the Custodian.

On September 23, 1944, Masakichi Miyasaki, father of the above mentioned, died at New Denver, B. C. The only asset of the Estate of Masakichi Miyasaki, deceased, was a credit balance with the Custodian, amounting to \$3,070.93. This Estate was administered by Mr. J. M. Streight, Official Administrator, New Westminster, B. C., and on July 19, 1946, Mr. Streight forwarded to this office a cheque for \$2,799.91, of which \$699.97 was credited to the account of Masaharu MIYASAKI.

No property interests, other than those mentioned above, are found on this file.
