## Re: Hidehiko SHIRAKAWA #00636

On March 13,1942, the day of his evacuation, SHIRAKAWA signed a statement to the Custodian reporting that he owned no property of any kind in the protected area.

In October, 1942, Genkuro MARUSE, File 2183, informed us that a trunk belonging to SRIRAKAWA was stored in a shed at the rear of 857 East Cordova Street, with the effects of Mr. NARUSE. A memorandum on file under date of December 15, 1942, would indicate that the trunk was found stored in this shed by Custodian agents, but it is believed that this is not correct, as there is no evidence that the goods in the shed were inventoried or checked in any way prior to October, 1944, when the goods were moved to 992 Powell Street. In October, 1944, the trunk belonging to SHIRAKAWA was apparently not found in the shed. There is no reply on file to our letter of January 16,1946, and from this we presume that the trunk was removed by its owner.
