

On December 2nd, 1942, we registered a Vesting Certificate covering Lots 38 & 39, Subdivision "B", Blk. 146, D.L. 264-A, believing at the time that D. Takayuchi ABE in Lots Thirty-eight (38) and Thirty-nine (39) in Subdivision "B" of Block One Hundred and Forty-six (146) District Lot Two Hundred and Sixty-four A (264-A) Group One (1) New Westminster District, Plans One thousand One hundred and twenty (1120) and One thousand seven hundred and seventy-one (1771), is vested in the Custodian, and hereby relinquishes and releases any right which he the said Custodian may have in the said property by virtue of the Vesting in him of the interest of the said D.
