In his declaration to the Custodian, dated Bank Accounts July 17, 1942, Jinzaemon MUKUDA stated that he had a Savings Account with the Royal Bank of Canada, East End Branch, Vancouver, B. C., in which there was a balance of approximately \$300.00. The Custodian investigated this matter and was advised that this account was closed out on September 14, 1942.

On his initial JP Form, dated July 17, 1942, MUKUDA Securities: declares that he was the owner of a \$50.00 Victory Bond and ten \$5.00 War Savings Certificates. However, in a later declaration, dated September 24, 1942, MUKUDA stated that he had eleven \$5.00 War Savings Certificates and had also paid \$10.00 on a \$100.00 Victory Bond at the Bank of Montreal, Port Alberni, B. C. In this connection the Bank of Montreal forwarded their Money Order, amounting to \$8.13, to this office, and same was forwarded to the Internee at the Camp.

The above-mentioned War Savings Certificates were forwarded to the Registrar, War Savings Certificates on May 18, 1946, and proceeds of same, amounting to \$48.25, credited to the account of the above noted Internee with the Custodian.

Chattels: In his declaration, dated September 24, 1942, MUKUDA stated that he had left one trunk and 1 cloth bag in charge of the B. C. Security Commission at Slocan, B. C. This was confirmed by letter from the Department of Labour on December 29, 1942, and the Internee requested that these articles remain where they were. No further action has been taken by the Custodian in connection with these articles.

In a letter, dated October 29, 1942, the B. C. Security Commission forwarded to this office cheque of the Department of Mines and Resources, amounting to \$11.40, representing wages due the above noted Internee. These funds were credited to MUKUDA'S account at this office.

On July 21, 1943, the B. C. Security Commission forwarded their cheque, amounting to \$5.70, representing a refund of transportation fare for this Japanese from Sproat Lake, Port Alberni to Vancouver, on March 10, 1942. These funds were credited to MUKUDA'S account with the Custodian.

No property interests, other than those mentioned above, are found on this file.
