GENERAL SUMMARY

Re: Mitsuko SUYEHRO-Reg. No. 10467, January 19, 1946.

This woman signed a declaration on March 24, 1942 stating that she owned no property. A Custodian release dated July 15, 1943, however, requested shipment of wedding gifts, silver ware etc. which she had left in the possession of Mrs. Greer, Prince Rupert.

It would appear that shipment was made as the sum of \$5.45 was paid from her husbands account to the B.C. Security Commission on September 17, 1943 to pay for the shipment of effects.

This file reveals no other property, and no liabilities are shown in this file.
