PERSONAL PROPERTY SUMMARYRe: ADACHI, Chuzo - Reg. No. 06730

He signed a declaration to the Custodian on March 24, 1942 and was evacuated on November 28, 1942. He declared that he was a laundry man formerly in the employ of Bloedel, Stewart and Welch. He lived with his parents at Bloedel.

CHATELS: He declared bedding and clothing in his own personal possession at Hastings Park. It is presumed that he took these with him when he was evacuated.

He also declared 1 Winchester Rifle, Type R, model 1894, Cal. 30-30, action L (Serial No. 673785) in the custody of Constable M. N. MacAlpine, Provincial Police, Campbell River. This gun did not come under the control of the Custodian. Firearms have remained in the custody of the R. C. M. P.

There is a letter on file, dated December 22, 1942, in connection with the shipment of a trunk and a box of china to Chuzo from 7225 Blenheim Street. Chuzo declared no chattels there, but, other members of the family did. The information received from the Department of Labour indicates that a trunk and a box were shipped on 15/1/43. Presumably this accounts for the letter on file.

BONDS: ADACHI declared (1) 1 \$500.00 Victory Bond deposited at the Canadian Bank of Commerce, Campbell River, B.C.  
(2) 1 \$50.00 Victory Bond in his own possession.  
(3) 1 \$100.00 Victory Bond at the Bank of Montreal, Main Branch, Vancouver, B.C. (for numbers of the bonds see back of J. P. form)

These bonds were not brought under the control of the Custodian.

BANK ACCOUNT: He declared three bank accounts:

- 1 - Canadian Bank of Commerce, Campbell River, B.C. Savings Account No. All6, amount \$372.26
- 2 - Japan & Canada Trust, Vancouver, B.C. Account A545 - \$2.90
- 3 - Bank of Montreal, Main Branch, Vancouver, B.C. Savings Account No. 10892 amount \$1,116.63.

None of these came under the control of the Custodian.

Regarding the Japan & Canada Trust Savings Co. it is to be noted that these accounts did come into our control. However no account of that number was listed in the J. & C. T. S. Co.'s list of accounts either current or savings. There was an account in the amount of \$22.01 in the name of C. ADACHI whose last known address was Camp #1, Bloedel, B.C. The last transaction was given as June 2, 1941. There was no account number given. We wrote to

both Chuzo, File 360 and his father Chika, File 358 (form letter 137) asking them whether either of them had an account with the Japan & Canada Trust Savings Co. and stated that unless we heard from them within a month from that date (February 17, 1944) we would assume that they had no interest in these funds. They did not reply. Evidently this account refers to someone else. The account declared by ADACHI Chuzo was probably closed by him between his declaration March 24, 1942 and his evacuation November 28, 1942.

LIFE

INSURANCE: ADACHI also declared a \$1,000.00 policy with the Monarch Life Insurance Co., the policy number being P 91660 and the beneficiary Chika ADACHI, his father. This was not brought under the control of the Custodian.

This file reveals no other property of any kind.
