When you registered with the Custodian on March 23, 1942, the only assets you declared were Victory Bonds and War Savings Certificates in your own possession and an account in the main branch of the Bank of Montreal, Vancouver, together with a balance of \$3.05 with the Japan and Canada Trust Savings Co.

The Victory Bonds and your account with the Bank of Montreal did not come into the custody of this office and as far as the Custodian is concerned you have been free to use these assets.

With reference to funds with the Japan and Canada Trust Savings Co., if you have not already received this money kindly send your pass book or account number for identification and a cheque will go forward. We would ask that you reply in this connection without delay using the enclosed stamped envelope.
