In so far as personal property on these files is concerned, a list of chattels appears on Files Nos. 10873 and 10874. These lists are, with some small exceptions, identical - that on the latter file being sworn before a Justice of the Peace by Sanji KONISHI in the presence of Father McGrath.

In view of the agreement sworn by Father McGrath (10874) before a J. P. on May 25th, stating that the farm will be operated and maintained in such a way that on the return of the KONISHI family it will be found reasonably in the same condition and that reasonable care will be taken of the property and effects, I consider that the chattels are fairly well cared for on this file. This especially, moreover, in view of Mr. Reed's report of June 29th, in which he says, "...I am firmly of the opinion that this office should not do anything that will disturb or interfere with the terms and conditions as set out in that agreement (between Konishi and the Oblate Fathers, dated May 25th)."
