This man signed a declaration to the Custodian on March 27, 1942.

In his declaration he reported furnishings for a 3 room house and a box of tools. On October 6, 1942, we received from FUKUMOTO an acknowledgment that the goods received into storage at 992 Bwell Street from Woodfibre represented all the chattels belonging to him left in the protected area. The tool box does not appear to be on this list, and presumably it must have been shipped to him from Woodfibre either before or after his evacuation. The camp stove and stove listed were shipped to FUKUMOTO in November and October, 1942. Three bedframes and 4 springs were shown on the list, but only one bed was sold, at the time the remainder of his chattels were disposed of by auction. It is assumed that the 2 beds and 3 springs unaccounted for were found to be unsaleable and were discarded. The net proceeds from the sale of his chattels amounted to \$14.50, which has been credited to his account.

He declared \$100.00 in War Savings Certificates in his possession. These did not come under the control of this office.

No other property is revealed by this file.
