

This 20-year old Canadian-born Labourer from Britannia Beach, signed a Custodian "JP" declaration form on the 23rd March, 1942.

He is single. He was evacuated on the 26th September, 1942.

Real Property: None.

Liabilities: None.

Personal Property: The only Personal Effects declared by this evacuee were "Clothing and bedding" in his own possession.

Bills Receivable: He declared the following sums to be owing to him.

\$125.00 by Mrs. E. Inouye (File 10790). *no funds, large debts.*
\$ 50.00 by S. Aratake (File 376). Paid by transfer June 6th, 1944.
\$ 30.00 by S. Takata. *never identified.*

Bonds, Shares, etc.: He declared ownership of a Victory Bond (\$50.00); 18 War Savings Certificates (8 \$4.00) and War Savings Stamps (\$3.00). These remained in owner's possession, and did not come under the administration of this office.

Bank Accounts: No action was taken by this office with regard to a balance of \$390.00 declared to be in an account with the Bank of Montreal, Hastings and Main Sts., Vancouver.

A balance of \$11.08 with the Japan & Canada Trust Savings Company was transferred by this office to the Bank of Montreal, Nelson, at Evacuee's request.

Funds: There is a credit balance of \$50.00 in this account at the present time.
