No record of any other goods, so presumably this

Sept. 1,1943 the sum of \$19.00 was received from the Treasury Dept. of Dept. of Labour for this man. No explanation of source of funds.

A total of \$136.26 was credited to this account, all of which has been released to him.

## MEMORANDUM TO INTERNEE FILE A33

## Re: Yaichi MIYABAKI, PW/A 497

With further reference to Memorandum of March 21, 1944, the boat sold at Ocean Falls, and listed as Ocean Falls Boat #6, is described in the survey report as,

"Gasboat - Y. Miyazaki

Engine - Farrow 5

Value (1942) \$20.00 (?)

This boat is very old and the engine is a two cycle of no value."

The B. C. Police reported this boat as a 12-foot boat with inboard Farrow engine, owned by Y. Miyazaki.

It is evident that this Farrow engine was left in the boat and not removed by Maval Service. See letter 13/6/42.

Engine 121 was reported variously as an Evinrude and as a Farrow engine. It was reported by Naval Service as being the property of Y. MIYAZAKI, of Ocean Falls.

Engine 121 carried serial number 1065/42874, and was a 2 cylinder 6 HP outboard, in poor condition with parts missing.

This engine may be the property of Y. Miyazaki, although Yaichi MIYAZAKI has not declared this asset.

On the other hand, the name Y. Miyazaki may have been placed on the engine by mistake in the first place. I think the money should be held until Yaichi MIYAZAKI says he owned such an engine, or until some other person claims this engine.
