This man signed a declaration to the Custodian on March 23, 1942.

In his declaration he reported 28 boxes and crates consigned to G. Yasui, 1548 West 2nd Avenue, Vancouver, at C.P.R. Wharf. In November, 1942, he confirmed that he had disposed of all his personal property before his evacuation.

He reported a debt of \$200.00 due him from his brother-in-law, *File 1268* Kazuo OTA, but on June 19, 1944, he informed us that he and Kazuo OTA had agreed to postpone settlement until after the war. This office therefore took no further action.

This file reveals no other property.
